The above locations are proposed for laying of BSNL OFC under NOFN for establishing Broad Band Connectivity to Gram Panchayaths along the existing road side in forest area. As the user agency has submitted a letter saying that the laying of OFC would be carried out by Horizontal Drilling method along the berm of the road and there is no requirement of felling of trees.

The proposed project passes through the Chincholi Wildlife Sanctuary and there are no protected archeological/heritage site/defense establishment or any other important monuments in the area. As there is no alternate route to lay the OFC, the requirement of Forest land as proposed by user agency (0.9215 ha) is the bare minimum for the execution of the said project. Therefore the diversion of forest land may be recommended as it is highly essential to provide broadband connectivity to the Gram Panchayaths.

There is no violation of Forest Conservation Act.-1980, in the proposed area.
