

of U.P. Government . In an earlier similar matter REC Chandigarh directed that Haryana Forest department to process the case , However has to take clear and unambiguous NOC from U.P. Forest Department . NOC in this regard has not been received . However a joint inspection with the U.P. forest department has been done. The User Agency has submitted to this office that requisite NOC will be provided by U.P. Forest Department within a month. Being a Govt. project of public interest

The case has been processed with a condition that NOC from U.P. Forest Department must be taken while considering the case . Grand total forest area proposed for diversion of U.P. and Haryana state is 3.5 Ha out of which 0.55 ha is of Haryana State and 2.95 ha of Forest area is of U.P. State.

The proposal is recommended for acceptance.
