SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF (for the forest land to be diverted under FCA)

7.1 A proposal has been received by this office from Irrigation Division P.M.G.S.Y. (P.W.D.) Champawat for diversion (under FCA-1980) of 9.14 ha of forest land/non forest land for non-forestry purpose. The project envisages the use of forest land for construction of Taknaguth to Danda Malla Motor Road. The site inspection of the land involved in the proposal has done by me on dated 03.11.2019

On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Protected forest measuring 9.14 ha.

The requirement of forest land proposed by the user agency in col.2 part-1 is unavoidable and is barest minimum required for the project.

Specific recommendation for acceptance or otherwise of the proposal.


The present Taknaguth to Danda Malla Motor Road Construction work, is proposed in mid of the forest area. Hence due to land transfer, the forest area would be separated in two parts, as a results of which the movement of wild life is to be affected. the construction of road will lead to increase in movement of vehicles as will as people incidents of illicit filling poaching man-animal conflict, accident of wild animal on road etc. may increase.

further this new allweather road will connecting with Danda village which further connects with Nandhaur Wild Life Sanctuary.

Hence forth the forest department need to be suitably equipped to handle the new challenges. the project is recommended with following additional demands for forest department.

1. Rs. 15 Lakh for Camper for patrolling.
2. Barring forest chowki in Danda Village, there is no other infrastructure of forest department. Rs 20 Lakh should be allotted for repair of FRH in Danda. if the repair is not possible, then new touring officer quarter would be constructed with this fund. this will be very useful for officer as wall as staff. who are on field visit, inspection, patrolling etc.
3. Rs. 10 Lakh should be provided for constructions of new barrier/Gate at a place decided the Director of Nandhaur Wild Life Sanctuary.
