5.1 A proposal has been received by this office from Uttar Pradesh Expressways Industrial Development Authority (UPEIDA), Government of Uttar Pradesh for diversion (under FCA-1980) of 4.0551 ha. of Reserve Forest and 2.2322 ha Protected Forest Total 6.2873 Forest Land for non-forestry purpose in Hardoi Forest Division.

The subject envisages the use of forest land for Development Ganga Expressway, an access controlled Greenfield Expressway from Village-Bijoli. District-Meerut to Village-Judapur Dando, District-Prayagraj of Uttar Pradesh. The project is passing through 12 Forest Division of Uttar Pradesh (viz. Meerut, Hapur, Bulandshahar, Amroha, Sambhal, Badanyu, Shahjhanpur, Hardoi, Unnao, Raibarely, Pratapgarh and Prayagraj) and involving a total of 121.4716 ha. of Forest Land. This proposal is prepared for the length of proposed Ganga Expressway falling in Hardoi Forest Division. The site inspection of the land involved in the proposal has been done by me on dated-26.11.2021

- 5.2 On inspection of the site, it is found that the land required by user agency is a Protected Forest 2.2322 ha. and Reserve Forest 4.0551 ha, total Forest Land 6.2873 ha.
- 5.3 The requirement of Forest Land as proposed by the user agency in Col. 2 of part-1 is unavoidable because no alternative land is available other than the proposed Forest Land in the project and is barest minimum required for the project.
