SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF

(for the forest land to be diverted under FCA)

5.1 A proposal has been received by this office from **Executive Engineer** construction Division P.W.D.Nainital for diversion under FCA-1980) of 3.555 ha. of forest land for non-forestry purpose. The project envisages the use of forest land for **construction of Motor Road Talla Ramgarh Motor Road KM 6 Kimupani Thandev To Semdhar to Saim Mandir MR**. The site inspection of the land involved in the proposal has been done by me on dated 07 - 09-2021

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring 3.555 ha. Van panchayat/Civilsoyam Land.

5.3 The requirement of forest land as proposed by the user agency in Col.2 part-1 is unavoidable and is barest minimum required for the project. **Yes**

उक्त प्रस्तावित मार्ग 5.00 किमी० लम्बाई तथा 9 मीटर चौड़ाई में प्रस्तावित किया गया था । जिसमें वन पंचायत 2.736 है० तथा सिविल एवं सोयम भूमि 0.819 है० तथा नाप भूमि 0.945 है० प्रभावित होती थी । उक्त प्रस्तावित मार्ग के समरेखण में वन पंचायत वन भूमि में 27 वृक्ष तथा सिविल एवं सोयम भूमि में 19 विभिन्न प्रजाति वृक्ष प्रभावित होते हैं तथा नाप भूमि में 25 वृक्ष प्रभावित होते हैं । जिसमें वन पंचायत में 8 बॉज प्रजाति के वृक्ष प्रभावित होते हैं । ऑन लाईन 46 वृक्षों की पृविष्टी की गई है जिसमें 8 बॉज प्रजाति के वृक्ष प्रभावित हैं । नाप भूमि में प्रभावित होने वाले 25 वृक्षों को ऑन लाईन टिप्पणी में अंकित किये गये हैं । स्थल निरीक्षण के दौरान स्थानीय जनप्रतिनिधियों तथा लो०नि०वि० के अधिकारी द्वारा अवगत कराया गया कि उक्त मार्ग के निर्माण से ग्राम हली एवं सकूना आदि के कुल 773 लगभग जनसंख्या हैं लाभान्वित होते हैं । अतः प्रस्ताव को भारत सरकार की स्वीकृति हेतु अग्रसारित किया जाता है ।
