4.00 <u>The Deputy Conservator of Forests, Sawantwadi Forest Division, Sawantwadi has</u> <u>certified that</u>:-

- 4.1 No suitable alternate non-forest land is available and the forest land required is barest minimum. (PPN-44 & 46)
- 4.2 The area belongs to Very Dense Forest, Eco class-I Category and having density of forest is above 0.5. (PPN-18 & 33)
- 4.3 Agreed to bear the cost of removal of the vegetation growth from the forest land proposed for diversion. (PPN-76)

- 4.4 The project is not included in the area of any National Park, Wildlife Sanctuary or Nature reserve. (PPN-70)
