 - m) Underground optical fiber cables, telephone lines & drinking water supply lines.
 - n) Setting up Medical Colleges by Government Departments.
- 7.1 Present proposal involves diversion of 5.00 ha. protected Forest land is covered under the activity at serial no. (l) mentioned above.
- 7.2 The State Government vide letter No FLD 2018/CR.143/F-10 Dated 15/05/2018 has conveyed its approval for constitution of Committee for approval of diversion proposal in Left Wing Extremist Affected area for more than 5.00 ha. & upto 40.00 ha. / OR having trees more than 50.00 ha. for purposed of critical public utility infrastructure facilities as declared by the Central Government vide letter F.No.11-9/98-FC(LWE) Dated 15/02/2018
- 7.3 As per clause 4.4, Public infrastructure in LWE Districts. It is mentioned in clause 4.4.3 for CA is applicable for all such proposals involving area up to 40.00 ha except for proposal up to 5.00 ha.with less than 50 trees per ha. (for area up to 5.00 ha with less than 50 trees) the provisions of planting as detailed in Section 3 of Chapter 2 shall be applicable.
- 7.4 The KML File CD of proposed CA land is enclosed and placed in file at top.
- 8.00 In view of this, the proposal is recommended to be placed before the Committee Constituted as per Government of Maharashtra GR Dated 15/05/2018 subject the following conditions.
- 8.1 The legal status of the forest land required will remain unchanged.
- 8.2 The User Agency shall defray the cost towards the compensatory afforestation at the prevailing rates.

- The forest land to be diverted shall not be used for any purpose other than specified in the project. 8.3
- The User Agency will defray the cost of Net Present Value of 5.00 ha. of forest land proposed for 8.4 diversion.
- The User Agency will defray the additional / revised cost of Net Present Value of forest land as 8.5 per the extant guidelines of Government of India.
- 8.6 The user agency shall obtain the environmental clearance, if required.

- 8.9 The user agency shall obtain the certificate of the Collector, Gadchiroli under the Scheduled Tribes and Other Traditional forest Dwellers (Recognition of Forest Rights) Act, 2006 before Stage II approval.
- The layout plan of the proposal shall not be changed without the prior approval of the Central 8.10 Government:
