

## RE-JOINT SITE INSPECTION REPORT

A proposal has been submitted under the Indian Forest Conservation Act-1980 for use of forest land for non-forestry purposes. The subject envisages the use of forest land for **Development of 8.5 MW Lashpathri-I Small Hydro Power Project (SHP) by Jammu and Kashmir Energy Development Agency (JAKEDA)**. The site inspection of the land involved in the proposal has been done by us on 02-04-2021.

On inspection of the site, it is found that the land required by the user agency is a forest land measuring 3.10 Hacs. The land proposed by the User Agency is the barest minimum required for the project and also the area so proposed doesn't house any unique flora & fauna. The linear measurements and calculations of the site for forest area is as under :
