A proposal has been received by this office from Nodal Officer and Conservator of Forests (FC) for diversion (under FCA-1980) of 0.892 ha. of forest land in favour of Siwani Water Services Division Bhiwani for deforestation from RD 0 to 10000, 11500 to 15000 & RD 16500 to 19000 on Bidola Minor in the work of remodelling of Bidola from RD 0 to 24600 having Chronic Tails to Feed, Distt. Bhiwani under Forest Division Bhiwani.

The site inspection of the land involved in the proposal has been done by me on dated **17.04.2022**.

- 1 **Felling of 684 Nos. of trees involved.**
- 2 On inspection of the site, it is found that the land required by the user agency is a forest area measuring **0.892 ha.**
