

The Chief Conservator of Forest, Mangrove cell, Mumbai has submitted Proposal under section-2 to the Deputy conservator of Forest, Thane vide his letter No. Land/1233, dt.03/09/2016. The same Proposal has been received from Deputy Conservator of Forest, Thane in this office vide his letter no. D-1/20/land/1600, Dt.25/11/2016 mentioned in the captioned subject. Xerox copies of the same letters of the CCF Mangrove, Mumbai and Deputy Conservator of Forest, Thane are enclosed herewith for ready reference. The Project Agency of this Project is Deputy Chief Engineer, SWD Municipal Corporation, of Greater Mumbai.

2.00 The Project Agency has submitted a Proposal for Construction of diversion of 0.2794 ha. land for Construction of Storm water pumping station on SNTD Nalla at Gazarbandh in Village Bandra at Santacruz, Near Khardanda, Mumbai (West). Therefore, the Project Agency is seeking Government of India's permission under section- 2 of Forest Conservation Act, 1980.

3.00 The forest area (Mangrove) required for this project is 0.2794 ha. The details of land proposed for diversion is as under.

4. The site inspection was also carried out by Divisional Forest Officer (Mangrove), Mumbai on 25.03.2016.
5. The area involved in this project does not form a part of Wildlife Sanctuary or National Park and not included in Protected Area. The site selected is 10.2 k.m. from the boundary of Sanjay Gandhi National Park, Borivali, Mumbai.
6. The Project Authority has given undertaking to pay the Net Present Value as directed by Forest Department and also for upward revision if any. The project Agency has submitted Necessary certificate/undertakings and Maps which are also enclosed in the Proposal.
7. The Project Authority has given an undertaking to submit necessary certificate regarding compliance FRA-2006 to be issued by Collector, Thane.

Scrutiny of the proposal has been carried out by the Chief Conservator of forest (Mangrove), Mumbai Mangrove Conservation Unit, Mumbai. This office has uploaded the proposal on the website.
