

The under signed has inspected the proposed site on date 12/07/2022, which is for diversion of proposal 0.0216 Ha. area of Reserved Forest (Notified u/s 4 of IFA 1927) Land survey No. 10 (New Gut No.25) for approach road to Gut No. 32/3 (Private Land) of village Karade Khurd, Tal. Panvel, Dist. Raigad, Dist. Raigad, Maharashtra. The total Reserved Forest (Notified u/s 4 of IFA 1927) area required for this project is 0.0216 ha.

No work has been started, hence violation of the Forest (Conservation) Act, 1980 has not seen. From the site inspection it appears that there was no soil disturbance and no trees are required to be cut on forest land diversion for approach road at village Karade Khurd.

PROJECT NOTE

The Project Authority Shri. Dinesh Patel, 1209 V times Square, Plot no. 3, Sector-15, Belapur, Navi Mumbai has submitted a proposal for diversion of 0.0216 Ha. Reserved Forest (u/s 4 of IFA, 1927) for approach road to private land Gut No. 32/3 in village Karade Kurd, Tal. Panvel, District Raigad in Maharashtra State.

The required Reserved Forest (u/s 4 of IFA, 1927) area is barest minimum for construction of approach road. The required land from village Karade Khurd S.No. 10 (New Gut No. 25) of Reserved Forest (u/s 4 of IFA, 1927) Tal. Panvel in Raigad District

The user agency has not started any work on proposed forest land.

This proposal is for approach road and bridge. This project involves less than 1.00 ha. forest land, therefore the compensatory non-forest land is not required. Hence, compensatory afforestation is proposed on 1.00 ha. degraded forest land. The degraded forest land identified for compensatory afforestation from Reserved Forest S.No. 1/0 (Gut No. 46/0) of village Karade Budruk, Taluka Panvel, Dist. Raigad. The project authority is willing to bear the cost of compensatory afforestation and all Government levies as required by the Government.

Therefore, this proposal has been recommended for diversion of 0.0216 ha. forest land for non-forest purposes.
