SITE INSPECTION REPORT

A proposal has been received by this office from Provincial Division Public Works Department Mirzapur diversion of 34.902Ha forest land and 18.004Ha non forest land Within Kaimoor Wild Life Sanctuary and E.S.Z for non forestry purpose. The subject envisages the use of forest land and non forest land new Construction of different roads Bhatwari-Matwar, Matwaria, Badohi-Parsia via Aura, Fuliyari, Silhata, Meza bandh-Sagra via Matehra and Kharihat-Kadwar road (Total length 37.79k.m.) Haliya range, Tehsil-Lalganj, District-Mirzapur. Diversion of Forest land (under Wildlife Protection Act 1972 and Forest Conservation Act 1980) of 52.906 Ha. (34.902 Ha forest land and 18.004 Ha Non Forest land) within Kaimur Wildlife Sanctuary. The land required to be diverted under Wildlife Protection Act 1972 and Forest Conservation Act 1980.

Site inspection of the land involved in the project has been carried out by me on dated 21/3/23. On site inspection it has been found that the project is passing through Kaimur Wildlife Sanctuary and forest outside sanctuary boundary which involves:

1. Forest Area within Kaimur Wildlife Sanctuary	:	34.202 Ha
2. Non Forest area within Kaimur Wildlife Sanctuary	:	14.504 Ha
3. Forest Area outside Kaimur Wildlife Sanctuary in E.S.Z.	:	0.700 Ha
4. Non Forest area Kaimur Wildlife Sanctuary in E.S.Z.	:	3.500 Ha
Total area within Kaimur-Wildlife Sanctuary (1+2)	:	48.706 Ha
Total Forest area (1+3)	:	34.902 Ha

The requirement of forest land and Protected area as proposed by the user agency in Form A, Part-I of FCA 1980 and Part I & II of WPA 1972 is unavoidable and is barest minimum required for the project.
