M/s P. P. Kharpatil through its authourised signatory Mr. Sagar Kharpatil has submitted a proposal for approach road and laying of underground Electric cable and 6"Dia. G.I. water pipeline through Reserved forest of village Vindhane and Chirner Taluka Uran in Raigad District, Maharashtra. This project requires 0.1911 ha. area of Reserved Forest and area, therefore the project authority is seeking GOI permission under Forest (Conservation) Act, 1980.

This proposal is for approach road, laying of underground electric cable and water pipeline. This project involves below 1.00 ha. forest land, therefore the compensatory non-forest land is not required. Hence, compensatory afforestation is proposed on 1.00 ha. degraded forest land. The degraded forest land identified for compensatory afforestation from protected forest S. No. 22D of Village Vindhane, Taluka Uran, Dist. Raigad. The project authority is willing to bear the cost of compensatory afforestation as required by the Government.

This proposal is for approach road, laying of underground electric cable and water pipeline which required less than 1.00 ha. forest land. Project proponent is ready to bear all the Government levies hence the proposal is being recommended for approval for diverting the required forest land under Forest (Conservation) Act, 1980 on the following conditions-

- 1) The legal status of forest land shall remain unchanged.
- 2) The area diverted will be used only for the purpose mentioned in proposal.
- 3) Cost of compensatory afforestation to be borne by the Project Authority.
- 4) Net Present Value to be borne by Project Authority.
- 5) User agency provide water to Forest department free of cost as it required for forestry work.
