# 13.0 Specific recommendation of the DY.CF.for acceptance or otherwise of the proposal with reasons:

Central Government, Ministry of Environment, Forests and Climate Change, New Delhi has given final approval for diversion of 55.74 ha. Forest area to ARAI for Laying down of test track for lab. under Forest (Conservation)Act,1980 vide letter dt. 24/07/2008 in which condition no. 15 i.e. "The diversion of land may be done after considering the issue of ARDE also." was laid down. The then Conservator of Forest, Pune vide letter dt.09/02/2009 gave permission to ARAI for non-forest use of the said land in accordance with the final approval for MoEF&CC vide letter dt.24/07/2008. Later, PCCF Nagpur revoked the said order passed by the then C.F., Pune for the reasons of non-fulfillment of condition no.15 in the final approval granted by MoEF&CC and also ordered user agency to not to start any work over the said area and not to divert the said land to user agency until any further orders are passed by State Government.

On dt.29/01/2019 this office has taken one sided possession of Vill-Kothrud forest, S.No.102 area of 98.045 ha.out of 105.74 ha.excluding the area 7.695 ha. under possession of ARAI. On dt.01/06/2018 Chief Conservator of forest (Mantralaya), Revenue& Forest Department Government of Maharashtra informed to the Secretary, Department of Defense, New Delhi about all facts about the issue of forest land in survey no.102 at Kothrud, Dist-Pune. In the letter para no.7 he mentioned that "permission for re-diversion cannot be accorded without prior written consent of the primary user agency."

About diversion of 55.74 ha.forest area to ARAI under Forest (Conservation) Act, 1980,APCCF& Nodal Officer,Maharashtra State Nagpur,has given report to Chief Secretary ,Revenue & Forest Dept.Mantralaya,Mumbai vide letter no. Nodal /RS-II/ID11293(5)/1308 dt. 04 /03/2021for necessary directions/ instructionsregarding diversion of land to ARAI. Currently the issue is pending with State Government for further directions

Meanwhile, proposal for diversion of 0.4620 ha. area for road was received from ARDE under the Forest (Conservation) Act,1980.In this proposal diversion the area of 0.15 ha. is overlaps with the area in the final approval accorded by the Central Government, MoEF&CC,New Delhi vide letter dt.24/07/2008 to ARAI.(map is attached on page no.98A)As mentioned in above para. the issue of diversion of land for ARAI is pending with State Government the diversion of overlapping land in

the proposal should also be decided at higher level or by State Government whichever the approval pertains to.

The APCCF&Nodal Officer ,Maharashtra state,Nagpur in his letter dated 27/12/2018 addressed to the Secretary (Forests),Revenue & Forest Dept.Mantralaya,Mumbai has recommended cancellation of approval given by the Central Govt. to the diversion of 55.74 ha.forest land to the ARAI & the ARAI may be asked to submit a fresh proposal under the FCA 1980 for diversion of 7.695 ha. of forest land.In his letter he has referred to the letter dt.19/06/2017 issued by the CCF(T)Pune in which it is mentioned that ARAI is not an Institution under control of Central Govt.but is a private company form by the Industrialists in the country.(Copy attached on page no.98B)

The APCCF&Nodal Officer ,Maharashtra State,Nagpur in his letter dated 04/03/2021 has recommended to the Principle Secretary (Forests),Revenue & Forest Dept. Mantralaya ,Mumbai to take decision on following points.

- 21.1) The CCF(T) Pune is to take possession of (55.74-7.65)=48.09 ha. Forest land immediately
- 21.2) To divert 7.695 hectares of forest land for use of ARAI
- 21.3) Balance amount is to be return to the ARAI after adjusting the amount paid by ARAI under Forest (Conservation) Act, 1980
- 21.4) The ARDE is to instructed to make proposal of 9.44 Ha. Forest land as per Forest (Conservation) Act, 1980. (Copy attached on page no. 98C)
  Still the above decision is awaited.
- The APCCF & Nodal Officer, Maharashtra State, Nagpur in his letter dated 04/03/2021 has Recommended ARDE to make proposal of 9.44 Ha. under Forest (Conservation) Act, 1980, meanwhile ARDE has submitted proposal of 0.4620 ha. Which is recommended for diversion & the proposed road to be open for use of forest department at all time. This proposal of road Under FCA 1980 by ARDE is being forwarded for necessary action in the national interest as the ARDE is an Institution under control of the Defence Production Dept. under the Defence Ministry.
