The Deputy Conservator of Forests, Thane has submitted the proposal mentioned in the subject vide his letter No. D-25/Survey/FCA/721, dated 15.07.2022. Xerox copy of the same is enclosed herewith for your ready reference. The Project Authority of this project is Shri. Vijay B. Aware, Executive Engineer, MSETCL, EHV Project Division, Kalyan - 421 301.

2.00 The Project Authority has highlighted that the Project is required in order to meet present and future power demand of Mumbai Suburban areas, Thane urban & rural areas and areas under Palghar District. Strengthening of power supply in Mumbai region which is commercial capital of India.

The proposal is of diversion of 12.0225 ha. Forest land for construction and laying of 220 KV LILO M/C. Transmission Line on 220 KV Padghe Wada & Kolshet Wada Transmission line for 400 KV Kudus sub Station passing through Thane District in the State of Maharashtra.

Therefore, the Project Authority is seeking Government of India's permission u/s.2 of Forest (Conservation) Act, 1980.

3.00 The Proposed Forest land required for this Project is 12.0225 ha. The details are as given below:-

- 4.00 The Project Authority has given an undertaking to pay the cost of Net Present Value as directed by the Govt. of India. The Project Authority has submitted necessary Certificates / Undertakings and Maps, which are also enclosed in the proposal.
- 5.00 The Deputy Conservator of Forests, Thane has certified that the proposed area for diversion of 12.0225 ha. of Forest land for construction and laying of 220 KV LILO M/C. Transmission Line on 220 KV Padghe Wada & Kolshet Wada Transmission Line for 400 KV Kudus Sub Station Passing through Thane District in the State of Maharashtra is 4.30 Km. from Tansa Wildlife Sanctuary. The nearest forest area at Village Eksal which is part of Tansa Wildlife Sanctuary ECO Sensitive Zone. The proposal area is not included in the area of National Park / Wildlife Sanctuary.
- 6.00 The Deputy Conservator of Forests, Thane has certified that the provisions of Forest (Conservation) Act, 1980 and guidelines under it has been violated in the Project. Extent of violation on forest land is 0.041476 ha. The Project Authority has accepted the violation and ready to compensate in terms of Penal Compensatory Afforestation, Penal Net Present Value. The Deputy Conservator of Forests, Thane has proposed penalty charges for violation. Violation report is attached with the proposal.
- 7.00 The Deputy Conservator of Forests, Thane has certified that there is cutting and felling of 669 numbers of trees in the project for diversion of 12.0225 ha. in the District of Thane. Number of trees to be felled Girth wise are as under, break up and felling estimate enclosed in the proposal.

- 8.00 The Project Authority has given undertaking that the FRA-2006 certificate from Collector Thane will be submitted before final approval of the Project.
- 9.00 The Deputy Conservator of Forests, Nanded has proposed area of 25.00 ha. degraded forest land of Reserved Forest details are as given below. Further certified that proposal degraded forest land is suitable for Compensatory Afforestation & Management purpose and also it is fee from encroachment. 10 years Compensatory Afforestation Scheme is enclosed with the proposal along with requisite maps.
- 10.00 The Deputy Conservator of Forests, Thane has certified, that the proposed Project is not likely to affect any monuments site of culture, historical, religious, archeological or recreational importance.
- 11.00 The Deputy Conservator of Forests, Thane has carried out Site Inspection on dated 12.04.2022. The Site Inspection report is enclosed in the proposal.
- 12.00 The Deputy Conservator of Forests, Thane's report is self-explanatory and this office agrees with the same.
- 13.00 This project is for diversion of 12.0225 ha. Forest land for construction and laying of 220 KV LILO M/C. Transmission Line for 400 KV Kudus Sub Station passing through Thane District in the State of Maharashtra which is infrastructure and public utility project. The Project proponent is ready to bear all the Government leuies and as per recommendation of the Deputy Conservator of Forests, Thane the proposal is recommended for acceptance and necessary approval u/s.2 of Forest (Conservation) Act, 1980.
