म.प्र. प.क्षे.वि.वि.कं.लिमि. खरगोन-द्वितीय द्वारा प्रस्तावित 11 के.व्ही. विद्युत लाईन मजरा टोला, भुरीखोदरी मुण्डिया की स्वीकृति हेतु ऑनलाईन प्राप्त प्रस्ताव में दर्शित खरगोन वनमण्डल के प्रशासकीय नियंत्रण में आने वाली वन परिक्षेत्र चिरीया के अन्तर्गत आरक्षित वनखण्ड मुख्य सतपुडा के कक्ष क्रमांक-732 एवं 733 वन परिसर चिरीया (उत्तर) में 11 के. व्ही. विद्युत लाईन बिछायी जाने के एकरेखण का मेरे द्वारा दिनांक .13.11.22 को संयुक्त स्थल निरीक्षण किया गया। प्रस्तावित क्षेत्र में 0.33 हे. वनभूमि की मांग न्यूनतम है तथा इसके अतिरिक्त अन्य कोई विकल्प नहीं है।
