

SITE INSPECTION REPORT

(Highlighting facts about proposal as required under column-11 of Part-II)

1. A proposal has been received by this office from **R. K. INFRACORP PRIVATE LIMITED** regarding **Temporary permission of installation of Hot mix plant and crusher plant for Widening and Strengthening of the existing approach road from Digdole to Bajmasta in Connection with construction of new Adit at Urnihal to the tunnel T49A on Katra Banihal Section of USBRL Project** for diversion of forest land under Forest (Conservation) Act, 1980 for non-forestry purposes. The project envisages diversion of **0.2421 hectares** of Forest land. The site inspection of the spot involved in the proposal has been done by the undersigned on **01-06-2022**.
2. On inspection of the site, it is found that the project requires diversion of **0.2421 ha** of Forest land falling in compartments **07/Ar and 8/Ar** Sangaldan Block Gool Range Ramban Forest Division.
3. The requirement of the forest land and felling of trees as proposed by the User Agency in Col-2 Part-I is unavoidable and bare minimum required for the project.
4. No Rare/Endangered/Unique species of flora and fauna in the area during the visit.
5. Violation of the Act has not been carried out by the User Agency and no work has been started without permission.
6. No protected/heritage site/defense establishment etc. is located along the current alignment.
7. No tree/Pole is coming under the alignment of the project which requires felling.
8. (b) **Specific recommendation for acceptance or otherwise of the proposal:-** Diversion of **0.2421 ha** forest land for “**Temporary permission of installation of Hot mix plant and crusher plant for Widening and Strengthening of the existing approach road from Digdole to Bajmasta in Connection with construction of new Adit at Urnihal to the tunnel T49A on Katra Banihal Section of USBRL Project**” is recommended for forest clearance under section-2 (ii) of Forest (Conservation) Act, 1980 in favour of User Agency **R. K. INFRACORP PRIVATE LIMITED** till the project period.
