Site Inspection Report for proposal for the diversion of 3.1884 ha of Forest land for construction of 2 Lane road from Ranipool to Pakyong (Airport) on NH-717 in East District of Sikkim by NHIDCL.

The necessary care shall be taken up to protect and conserve the Bio-diversity of the area.
