The User Agency has highlighted that the Ministry of Road Transport & Highways (MoRTH), GOI has decided to takep up the development of Section-I – Shahapur Patgaon NH-548A in the State of Maharashtra for augmention of capacity for safe and efficient movement of traffic by upgrading to Two Lane with paved shoulder configuration based on the traffic demand. - As per GOI guidelines dated 08/11/2017 at least 1000 plants per ha. to be planted on degraded forest land identified for compensatory afforestation.
- 6.3 The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the forest Department by the project authority.   - 4. Deputy Conservator of Forests, Shahapur has certified that:-
    - 4.1 No suitable Non forest land is available for the proposed project and demand for the forest land is minimum.
    - 4.2 The proposed project is located on existing alignment of the NH-548A. No Need to examine the alternate route for this purpose, only new re-alignment for new bypasses has been taken up by the project proponent in non-residential area through private land acquisition.
    - 4.3 Provisions of the Forest (Conservation) Act, 1980 and guidelines, under it, have been violated by user agency.

The User Agency has violated over 0.0503 ha area. Work started on 01/01/2019 and work stopped on 02/01/2019. The forest offence case is booked and the penalty of Rs. 279200/- has been recovered . Violation report submitted.

4.4 34.02 ha degraded forest land as per details mentioned below has been identified for Compensatory afforestation. The said land is suitable for afforestation and management purpose and also it is free from encroachment and encumbrances:-

#### 4.6 Wildlife Cert :-

- The proposed area is not passing through any Notified Protected Area (PA) including Wildlife Sanctuary, National Park.
- The nearest Tansa Wildlife Sanctuary is located 3.09 km away from project boundary. Thus no impact on wildlife.
- 4.7 Certified that, the area proposed under the project does not included in the definition of Identified Forest as defined by Hon'ble Supreme Court of India in W. P. 202 of 1995.
- 4.8 The proposed area is not likely to affect any monument site of cultural , historical religious, archeological or recreational importance
- 4.9 The proposed area belongs to Eco Value Class I, Dense Forest & Open forest having density below 0.3 to 0.4.
- 4.10 There are total 2586 No of trees felling/cutting involved in the project . Girthwise details of trees are as under :-

- 5.4 User Agency has not submitted the FRA-2006, However submitted the undertaking stating the same will be submitted on receipt from District Collector Thane or with Stage-1 compliance.

- 5.6 The project authority has submitted the Administrative / Technical Approval issued by GOI, Ministry of road Transport & Highways vide letter dt. 16.01.2018.
- 6. In view of this, the proposal is recommended for approval under section 2 (ii) of the Forest (Conservation) Act, 1980 subject to the following conditions:

- 6.3 The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey , demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the forest Department by the project authority. The CA will be maintained for 10 years . The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- 6.4 The user agency will defray the cost of Net Present Value of 17.010 ha. of forest land as per the latest Guideline of Government of India.
- 6.5 For violation of the FCA, 1980 as penalty, the user agency will defray the cost (equal to NPV of forest land per hectare for each year of violation from the date of actual diversion as reported by the inspecting officer with maximum upto (5) five times the NPV plus 12 percent simple interest till the deposit is made in accordance with Government of India advisory number 11-42/2017-FC, dated 29/01/2018.
- 6.6 The user agency will defray the additional / revised cost of Net Present Value of forestland as per the latest Guideline of Government of India.
- 6.7 The user agency will defray the cost of removal of 2586 trees in the proposed area. However, minimum number of trees will be felled. In situations where felling of trees is avoidable and such trees could be transplanted, all efforts to transplant such trees at a pre designated site will be taken and additional expenditure, if any, in such cases shall be at the cost of the User Agency.
- 6.8 The user agency should submit the complete compliance of FRA-2006 at the earliest or along with compliance of Stage-I approval.
- 6.9 User agency shall raise strip plantation on both side and Central verge of the road as per IRC norms.
- 6.10 Speed regulating signage will be erected along the road at regular intervals in the Forest areas.

- 6.3 The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey , demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the forest Department by the project authority. The CA will be maintained for 10 years . The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- 6.4 The user agency will defray the cost of Net Present Value of 17.010 ha. of forest land as per the latest Guideline of Government of India.

- 6.8 The user agency should submit the complete compliance of FRA-2006 at the earliest or along with compliance of Stage-I approval.
- 6.9 User agency shall raise strip plantation on both side and Central verge of the road as per IRC norms.
- 6.10 Speed regulating signage will be erected along the road at regular intervals in the Forest areas.
- 6.11 The user agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, , if applicable

- 6.12 The boundary of the diverted forest land shall be demarcated on ground at the project cost by erecting four feet high reinforced cement concrete pillars, with chain link fencing on both side of land so diverted and which bifurcates Reserved/Protected Forest to protect encroachment on forest land in future.
- 6.13 The user agency in consultation with the State Government shall create and maintain an alternate habitat/home for the avifauna, whose nesting trees are to be cleared in this project. Bird's nest artificially made out of eco-friendly material shall be used in the area., including forest area and human settlements, adjoining the forest area being diverted for the project.
- 6.14 The layout plan of the proposal shall not be changed without prior approval of Central Government.
- 6.15 No labour camps shall be established on forest land.
- 6.16 Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 6.17 The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest officer.
- 6.18 No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 6.19 The forest land shall not be used for any purpose other than that specified in the project proposal
- 6.20 The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt of India.
- 6.21 It Shall mandatory to provide underpass for safe crossing of wild animals
  - (a) The underpass shall have a minimum size of width 4.00 mt and Height 3.00 mt.
  - (b) Wherever natural cross drainage works are in existence, then no need to construct new underpass subject to existing structure nearly complying above mentioned dimensions, as suggested in (a) above.
  - (c) Wherever natural cross drainage works are in existence but as per engineering requirement, it is required to reconstruct then that structure shall comply with the minimum dimensions as suggested in (a) above.
  - (d) Interval between such underpasses shall not be more than 2.00 km.
  - 6.22 Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guidelines F No 11-42/2017-FC dated 29/01/2018.
- 6.23 Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & Wildlife.
- 6.24 All other conditions as may be mandatory under relevant Acts, rules and guidelines shall be complied with by the user agency.
- 7. It is therefore requested that the Government of Maharashtra may kindly be moved to approve the diversion of 17.01 ha. Reserved/Protected Restored Private Forest land in favour of Executive Engineer, Maharashtra State Road Development Corporation (Ltd.), Mumbai for

Rehabilitation and Up-gradation of Shahapur Patgaon Section  $1-(KM\ 0+000\ to\ KM\ 20+130)$  part of NH-3 Shahapur – Murbad – Patgaon – Karjat – Khopoli – NH4 section of newly declared NH-548 A in the state of Maharashtra under section 2 (ii) of the Forest (Conservation) Act, 1980.
