SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF (For the forest land to be diverted under FCA)

A proposal has been received by this office from **Chief Manager Project I.H.B. LTD., Indian Oil Bulling Sector-F, Kapoorthala Aliganj Lucknow** for Kandala-Gorakhpur LPG Pipe Line (KGPL) Project (Unnao-Gorakhpur Section) for laying of Underground LPG Pipe Line Along with Optical Fiber Cable (OFC) in Sahjanwa Range NH-28 Bokta to HPCL Plant 0.047 Ha. & Bansaon Range NH-29 Gorakhpur-Varanasi Road 0.0030 Ha. Diversion under (Forest Conservation Act, 1980) of Total 0.050 Hect. Protected forest land and 32 tree cutting is involved for Non Forestry Purpose in laying of Underground LPG Pipe Line Along with Optical Fiber Cable (OFC).

The site inspection of the land involved in the proposal has done by me on dated 22.9.2024 On inspection of the site, it is found that the land required by the user agency is a Protected Forest measuring **0.050 ha.**

The requirement of forest land as proposed by the user agency in Part-1 of Form-A is unavoidable and rarest minimum required for the project.
