The proposed forest area requested for laying of underground Optical Fiber Cable (OFC) is in *Kiluvamalai Reserved Forest* in Madurai Range in Madurai forest division.

The underground Optical Fiber Cable (OFC) has proposed to be laid on the left side of the existing Madurai – Natham main road to Saranthangi Village to a distance of 1.10 km with Trench width of 0.30m.

There is no felling of trees involved in this proposal. The User Agency has not done any works in the proposed area in violation of the provisions of Forest (Conservation) Act, 1980. The proposed forest area doesn't fall in the Eco Sensitive Zone of Megamalai and Kodaikanal Wildlife Sanctuaries. Based on the recommendation of the District Forest Officer, Madurai the diversion of forest land to an extent of 0.033 ha in Kiluvamalai Reserved Forest of Madurai Range in Madurai Forest Division is recommended.
