

**SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF**  
 (for the forest land to be diverted under-FCA)

5.1 A proposal has been received by this office from अधिकारी प.म.स.वा. विभाग, जल्दी for diversion under FCA-1980 of 0.8370 ha of forest land for non-forestry purpose. The project envisages the use of forest land for construction of संकेत विधान सभा. The site inspection of the land involved in the proposal has been done by me on dated 24-8-2019.

5.2 On inspection of the site it is found that the land required by the user agency is a RF/PT/un-classed other forests measuring 0.8370 ha. Revenue Forest, am
