Specific recommendation of the Forest Divisional Officer for acceptance or otherwise of the proposals with reasons. The diversion of forest area of 1.5259 Ha for a total length of 1525.9M and width of 10.00 M for formation of road and laying of BT from from Chamanpally to Kushnepally of Vemanpally Mandal in Mancherial District in favour of DPRE – PIU Mancherial <u>is recommended</u> subject to the following conditions:

A) (2) No's of Animal passages of width minimum of 30.00 m length and 2.75 m height as per the specific guidelines, designs and norms for construction of under passage as specified by the MoEF&CC shall be formed by the UA at Comp.no. 126- (2) Animal passages (culverts) i.e., Latitude 19.0865740 N Longitude - 79.7146070 E, Latitude 19.0851640 N Longitude 79.7179690 E.

for easy crossing of animals preventing disturbance and road kills. The chain link fencing shall be placed on either side of the passages on both sides of road to a length of 100m in a funnel model for diverting the wildlife towards animal passages for easy crossing of animals preventing disturbance and road kills.

B) The chain link fencing shall be erected on either side of the passages on both sides of road to a length of 100m in a funnel model for diverting the wildlife towards animal passages.

C) Speed Breakers should be provided for every 100 M to limit the speed of vehicles below 30 Kmph.

D) Caution signages should be provided.

 Since there is movement of Tiger and other wildlife, the wildlife mitigation measures are proposed.
