FIELD INSPECTION NOTES OF THE DISTRICT FOREST OFFICER. MAHABUBABAD ON 20.09.2021 IN CONNECTION WITH THE PROPOSED DIVERSION OF 1.7844 Ha. FOREST LAND IN WLM GUDUR DIVISION OF MAHABUBABAD DISTRICT FOR LAYING OF OPTICAL FIBER CABLE ALONG THE ROAD WITHIN THE EXISITING ROW FOR EXECUTION OF T-FIBER PROJECT IN MAHABUBABAD DISTRICT IN FAVOUR OF M/s. TELANGANA FIBER GRID CORPORATION LIMITED

As per the proposal for diversion of forest area received and request made by the M/s. Telangana Fiber Grid Corporation Limited, I have inspected the site on 20.09.2021 for Laying of Optical Fiber Cable along the road within the existing row in Compt.No.749 of Pakhal Reserve Forest, Compt.Nos.720, 721 & 722 of Pakhal Reserve Forest, Compt.Nos.704, 705, 706 & 707 of Pakhal Reserve Forest, Compt.No.674/2 of Khanapur Reserve Forest, Compt.Nos.1107 & 1108 of Guduru Reserve Forest, Compt. No.1106 of Guduru Reserve Forest, Compt.No.1102 of Guduru Reserve Forest, Compt.Nos.1109 a & b of Guduru Reserve Forest, Compt.No.1097 of Guduru -I Reserve Forest, Compt.Nos.1102 & 1085 of Guduru Reserve Forest, Compt.Nos.1077, 1078, 1079 &1081 of Guduru Reserve Forest, Compt. No.1045 of Ponugodu Reserve Forest, Compt.No.1043 of Ponugodu Reserve Forest, Compt.Nos.1036 & 1037 of Ponugodu Reserve Forest, Compt.No.1050 of Guduru Reserve Forest, Compt. No.1002 of Guduru Reserve Forest, Compt.Nos.1116, 1001 & 999 of Guduru-I Reserve Forest, Compt. No.988 of Guduru-I Reserve Forest, Compt. No.951 of Guduru-I Reserve Forest, Compt.Nos.950, 958 & 990 of Guduru-I Reserve Forest which are falling in the Pakhal Wild Life Sanctuary area, Compt. Nos.917 & 918 of Chintaguda Reserve Forest which is falling in the Eco Sensitive Zone Area along with concerned Forest Range Officers, Gudur and Kothaguda. The User Agency has requested for diversion of 1.7844 Ha of Forest land for Laying of Optical Fiber Cable along the road within the existing row.

The proposed Optical Fiber Cable is passing through the Wild Life Sanctuary area with an extent of 1.6745 Ha. and the remaining area to an extent of 0.1099 Ha. is passing through the Eco Sensitive Zone Area. The User Agency, M/s. Telangana Fiber Grid Corporation Limited has got the area demarcated on the ground. The proposed area having the forest of 0.1 to 0.4 density. The breakup of the area required by the User Agency is as follows:

I have inspected the site along with the Forest Range Officers, Gudur, Kothaguda and Gangaram along with concerned staff and it was observed that the above forest area is Wildlife Sanctuary area and Eco Sensitive Zone Area and there is no tree growth on the

proposed Fibre Cable for diversion in Pakhal, Guduru, Khanapur & Guduru-I Reserve Forest of Kothaguda Range, Guduru, Guduru-III, Guduru-IV & Ponugodu Reserve Forest of Guduru Range, Chintaguda Reserve Forest of Gangaram Range. It is observed that the proposed Fiber Cable width can be restricted such that there is no tree felling is required where ever there are trees and in areas where there are no standing trees, the Fiber Cable width as requested by the User Agency is recommended.

The wildlife in the surrounding forest areas are Tiger, Leopard, Wild boar, Spotted Deer, Chousinga, Hare, Peacocks, Sambar, etc.,

Further, it is submitted that, as per the report submitted by the Forest Range Officer, Gudur, she has stated that, the User Agency has violated the Forest Conservation Act, 1980 Rules and booked a POR vide POR No.8471/170, dt:06.07.2021 towards illegal digging of Gravel for laying of the Optical Fiber and transportation by tractor to a tune of 61.484 Cmt. @ Value Rs.27,114/-.

The User Agency has submitted their undertakings to implement the following conditions:

The proposals for diversion of forest land to an extent of 1.7844 Ha. in Guduru (W.L.M.) Division of Mahabubabad District for Laying of Optical Fiber in the Wildlife Sanctuary area and with 0.45 Mtrs. Width and there are no trees falling in the proposed area and no flora and fauna will be damaged for the project.

Hence, the proposals for Laying of Optical Fiber Cable in Compt.No.749 of Pakhal Reserve Forest, Compt.Nos.720, 721 & 722 of Pakhal Reserve Forest, Compt.Nos.704, 705, 706 & 707 of Pakhal Reserve Forest, Compt.No.674/2 of Khanapur Reserve Forest, Compt.Nos.1107 & 1108 of Guduru Reserve Forest, Compt. No.1106 of Guduru Reserve Forest, Compt.Nos.1102 of Guduru Reserve Forest, Compt.Nos.1109 a & b of Guduru Reserve Forest, Compt.Nos.1109 a & b of Guduru Reserve Forest, Compt.Nos.1097 of Guduru –I Reserve Forest, Compt.Nos.1102 & 1085 of Guduru Reserve Forest, Compt.Nos.1045 of Ponugodu Reserve Forest, Compt.No.1043 of Ponugodu Reserve Forest, Compt.Nos.1036 & 1037 of Ponugodu Reserve Forest, Compt.No.1050 of Guduru Reserve Forest, Compt. No.1002 of Guduru Reserve Forest, Compt.Nos.1116, 1001 & 999 of Guduru-I Reserve Forest, Compt. No.988 of Guduru-I Reserve Forest which are falling in the Pakhal Wild Life Sanctuary area, Compt. Nos.917 & 918 of Chintaguda Reserve Forest which is falling in the Eco Sensitive Zone Area which are falling in Gudur, Kothaguda and Gangaram Ranges is recommended with the following conditions.

- 1. The Legal status of the Wildlife Sanctuary area proposed to be diverted does not change.
- 2. Conditions imposed by District Forest Officer, Mahabubabad shall be followed by the User Agency are as follows:

- Any other conditions imposed by the District Forest Officer, Mahabubabad from time to time shall be followed by the User Agency.

The Proposals for diversion of 1.7844 Ha (of which 1.6745 Ha of Wildlife Sanctuary area and 0.1099 Ha of Eco Sensitive Zone Area) for Laying of Laying of Optical Fiber Cable along the road within the existing Right of Way is recommended by the District Forest Officer, Mahabubabad.
