



The Deputy Conservator of Forests, Shahapur has submitted the proposal mentioned in the captioned subject vide his letter No. A/20/Land/242, dated 05.05.2016 & A/20/Land/2186, dated 26.12.2016. Xerox copy of the same is enclosed herewith for your ready reference. The Project Agency of this project is Shri. Raju Baban Dhanve, village Kalambhe, Tal. Shahapur, Dist. Thane.

2.00 The Project Authority has submitted a proposal for diversion of 0.467 Ha. Forest land for approach road towards their own Private Non Forest Survey No.214 pt. of village Aasangaon. Therefore, the Project Authority is seeking GOI's permission u/s.2 of Forest (Conservation) Act, 1980.

3.00 The Forest area required for this Project is 0.467 Ha. The details of forest land proposed for diversion are as under:-

- 4.00 The area involved in this proposal does not form part of any existing National Park, Wildlife Sanctuary, Nature Reserve etc.
- 5.00 The Project Authority has given an undertaking to pay the cost of Net Present Value as directed by the Govt. of India. The Project Authority has submitted Necessary Certificates / Undertakings and Maps which are also enclosed in the proposal.
- 6.00 The proposed area i.e. 0.467 Ha. from villages Aasangaon & Kalambe of Shahapur Taluka falls within 10 kms. from the boundary of Protected area, Tansa Wildlife Sanctuary. The Deputy Conservator of Forests, Shahapur certified that, said Project shall not have any adverse effect on the Wildlife within National Park/Sanctuary.
- 7.00 The Project Authority of this proposal i.e. Shri. Raju Baban Dhanve has already done non Forestry work without prior permission, constructed road and erected electric poles in 0.467 ha. demanded forest area. Therefore there is a violation of Indian Forest Act 1927 and Forest (Conservation) Act 1980. Atgaon Round Forest Offence case vide No.M/24/2011-12 and M/01/2013-14 is booked against Shri. Raju Baban Dhanve and Criminal Case is also lodged against Shri. Raju Baban Dhanve in the Court of J.M.F.C., Shahapur and the matter is in Court.

Deputy Conservator of Forests, Shahapur was directed to get explanation and report in prescribed format regarding violation from MSEB in this regard. Deputy Conservator of Forests Shahapur had submitted his report along-with prescribed format regarding violation of MSEB, is attached in the Proposal.

- 8.00 After scrutiny of the proposal it is seen that the Project Authority has submitted proposal for regularization / sanction for already constructed road and electric poles under Forest (Conservation) Act 1980. An Undertaking has been given by the Project Authority for payment of fine as directed by Government as per law. The same is enclosed in the proposal. The required report in prescribed format regarding violation as per G.R. dated 02/12/1993 along with note regarding circumstances under which the work has undertaken in violation of Forest (Conservation) Act 1980, is attached in the proposal.
- 9.00 The User Agency had applied for the FRA - 2006 certificate from Collector Thane. Regarding to this, the necessary undertaking is submitted and the same is enclosed in the proposal by Project Authority. The Project Authority may be asked to submit FRA certificate before recommending the proposal to Government of India.


- 10.00 The Deputy Conservator of Forests, Shahapur has certified, the proposed Project is not likely to affect any monuments site of culture, historical, religious, archeological or recreational importance.
- 11.00 The Deputy Conservator of Forests, Shahapur has carried out site inspection on 05.05.2016. The site inspection report is enclosed in the proposal.
- 12.00 The Deputy Conservator of Forests, Shahapur's reports are self-explanatory and this office agrees with the same.
- 13.00 As per the recommendation of the Deputy Conservator of Forests, Shahapur, there is no alternative approach road to reach their private land without the constructed approach road. The road is also available for nearby villages for their use. The proposal is recommended on condition to recover Net Present Value, Cost of Afforestation and also take penal compensatory Afforestation action as per directions of Government of India for violation done by the Project Authority.
- 13.00 Four sets of proposals are enclosed herewith with all required documents for further necessary action. Proposal is submitted online vide No. **FP/MH/ROAD/16327/2015**.
