2.00 The proposal has been initiated by Additional Director, Chandrapur Forest Academy of Adm. Dev & Management, Chandrapur for seeking approval under Forest (Conservation) Act, 1980. Previously, the proposal admeasuring 28.00 ha. forest land has been formally approved by the Government of India vide letter No. FC-II/MH-62/2017-NGP/2985, dt.6/12/2017. Subsequently, the State Government vide letter No.FLD-3617/CR.153/F-10, dt. 7/12/2017 has also issued diversion order to the project under the Forest (Conservation) Act, 1980. The user agency has also submitted the proposal for diversion of 16.56 ha forest land for extension of the Forest Academy and the same has been submitted by the State Government to the Central Government vide letter dt.29/5/2019 for prior approval under the Forest Conservation Act, 1980. The said project was placed in 51<sup>st</sup> meeting of the Regional Empowered Committee held on 20<sup>th</sup> August, 2019. The Committee after detailed examination and discussion on the proposal decided to approve the proposal for diversion of 10.33 ha only out of the proposed 16.56 ha forest land under the Section-2 of the Forest (Conservation) Act, 1980 subject to fulfillment of general, standard conditions,

3.00 At present the construction and infrastructure development for the Forest Academy is in progress. As per the site inspection report of the MSEDCL Officer, it has been reported that the existing power supply shall not be sufficient for the new proposed construction of the Forest

Academy as existing sub-station is situated at Banagli camp which is far away and therefore continuous power supply to the extent of 2.16 MW to the Forest Academy is inadequate. Hence, to increase sufficient power supply to the newly proposed infrastructure of the Forest Academy, the proposal for diversion of 0.85 ha forest land for construction of 33/11 KV Sub Station has been proposed by the User Agency. The site inspection report is enclosed on page no.69 to.70.

## 4.00 The Divisional Forest Officer, Chandrapur Forest Division, Chandrapur has certified that:-

- 4.1 the area belongs to Eco-value class-III and having density 0.1 Open Forest.
- 4.2 alternate alignment is not possible and the forest land required is the barest minimum.

- 4.4 the proposed project is not likely to affect any monumental site of cultural, historical, religious, archeological or recreational importance.
- 4.5 area of 0.85 ha. Reserved Forest land proposed for diversion has been demarcated on the spot by fixing boundary stone around the area.
- 4.6 the proposed area for the project is not within the 10.00 km from the boundary of the protected area.
- 4.7 the area involved in the project does not form part of any existing National Park, Wildlife Sanctuary, Nature Reserve.
- 4.8 the non-forest area covered under the project is not under the provision of Maharashtra Private Forest (Acquisition) Act 1975 by virtue of application of Section 35 of Indian Forest Act 1927 and are not recognized as deemed reserved forest as well as not included in the area identified as "forest" as per dictionary meaning of forest as intimated to the expert committee appointed under interim judgment of the Hon'ble Supreme Court dated 12/12/1996.
- 4.9 there is no cutting and felling trees involved in the implementation of the project.
- 5.00 Government of India vide letter No.11-43/2013-FC, dt.3/12/2018 has issued guidelines regarding compliance of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forests Right) Act, 2006. As per these guidelines:-

'Accordingly, it is clarified that within the time period stipulated for compliance of Stage I condition, Deputy Commissioner shall complete the process of compliance of FRA (including forwarding its findings to be concerned CF), hence for the purpose of the MoEF & CC, as per the provisions under the Forest (Conservation) amendment rules, 2016 the compliance under FRA is not required for consideration of in-principle approval. This has to be furnished by the State Government for consideration of the proposal by the Ministry for final approval'.

Hence, the user agency has given an undertaking regarding the compliance under the Scheduled Tribes and Other Traditional forest Dwellers (Recognition of Forest Rights) Act, 2006 has been applied and is under process and shall be submitted before in-principle approval.

- 5.2 No Compensatory Afforestation is required as there is no felling of trees involved implementation of the project and the area proposed for diversion less than 1.00 ha.

- 6.6 The user agency shall provide fuels preferable alternate fuels to the labours and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
- 6.7 The boundary of the diverted forest land shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, forward and back bearing and distance from pillar to pillar.
- 6.8 The layout plan of the proposal shall not be changed without the prior approval of the Central Government.
- 6.9 The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central government.
- 6.10 No damage to the flora and fauna of the adjoining area shall be caused.
- 7.0 The user agency shall undertake comprehensive soil conservation measures at the project cost in consultation with the state Forest Department. An approved, plan indicating such measures shall be submitted along with the compliance of Stage-I approval.
- 7.1 No felling of trees shall be undertaken during the implementation of the project. The State Forest Department shall ensure strict compliance of this condition.
- 7.2 The user agency shall obtain the certificate of the Collector, Chandrapur under the Scheduled Tribes and Other Traditional forest Dwellers (Recognition of Forest Rights) Act, 2006 after Stage I approval.
- 7.3 The forest land shall not be used for any purpose other than that specified in the proposal.

7.4 All other conditions as may be mandatory under relevant Acts, Rules and guidelines shall be complied with by the user agency.
