Yavatmal in the State of Maharashtra.</p> <p>The scope of work covers making of trench of size 80 cm x 100 cm x 847 mtr = 0.0847 Km for laying of 11 KV multi core cross linked polythene insulated power cable (XLEP) along the road side within ROW from Godhani power station via Rukamini Pandurang Sansthan, Oxygen Park to MJP office premises . This line passing through forest area is 847 Mtrs long. For laying of power cable duly excavation, RCC Hume pipe will be used 90 cm below ground level along road side. Necessary back filling with light ramming shall be carried out to make ground surface as it was. There is no requirement of felling of trees.</p> <p>Purified water lifted from office premises pump to various MBR's to supply water to the beneficiary consumer in Yavatmal city. Pure water will be supplied to the consumer in Yavatmal city.</p> <p>Due to expansion of city area, demand for pure water supply increasing is day by day.
