Site Inspection Report for proposal for the diversion of 1.58ha of Forest land for construction of security and administration block at Rorathang in East District of Sikkim by CIPLA II Ltd.

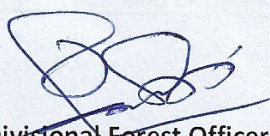
