
SITE INSPECTION REPORT

1. A proposal of **Executive Engineer PWD (R&B) Spl. Sub Division Doda** is recommended by DFO Social Forestry Division Doda in Parivesh Portal for diversion of Forest land under Forest conservation Act 1980 for non forestry purpose. The project envisaged diversion of 0.301 hac of forest land at Social Forestry Division Doda in District Doda in favour of **Executive Engineer PWD (R&B) Spl. Sub Division Doda** for Construction of Link road from Udyanpur to Rai Sarwala km 1st to km 5th in the UT of J&K in Social Forestry Division Doda. The site inspection of the spot involved in the proposal has been done by the Divisional Forest Officer Social Forestry Division Doda on **18-04-2022**.
2. No protected / heritage site / defence establishment etc is located in the area.
3. No Rare/endangered/unique species of flora and fauna found in the area. Leopard Jungle cat etc. do exist in the area but construction of this road does not affect their survival.
4. No violation of the Act has been carried out by the user agency as the work for this proposal is yet to be started which shall be allowed only after clearance of the proposal by competent authority.
5. Whether site, where the forest land involved is located has been inspected by concerned Conservator of Forests (No).
6. Whether the concerned Conservator of Forests agree with the information given in Part-B and the recommendations of Divisional Forest Officer (Yes).
