Sub: Forests - Forest (Conservation) Act, 1980 - Vellore Forest Circle / Tiruvannamalai Forest Division - Diversion of 0.47 ha of forest land in Veerappanur and Palamarathur RFs for construction of 21 number of retaining walls in various places of Polur-Jamunamarathur-Alangayam-Vaniyambadi road from km 37/2 to 50/8 of SH-215) in Tiruvannamalai District in favour of Divisional Engineer, Highways, Construction and Maintenance, Tiruvannamalai District – Forwarding off – Regarding.

I wish to state that the Divisional Engineer, Highways Department, Construction and Maintenance, Tiruvannamalai has uploaded online application under Section 2 of Forest (Conservation) Act, 1980 for of 0.54 ha of forest land in Veerappanur and Palamarathur RFs for construction of 23 number of retaining walls in various places of Polur-Jamunamarathur-Alangayam-Vaniyambadi road from km 37/2 to 50/8 of SH-215) in Tiruvannamalai District under proposal No. FP/TN/Road/44088/2020

- 2) Brief details of the project is given below.
- i) The User Agency has uploaded the proposal in the prescribed format of Form A Part I under Section 2 of the Forest (Conservation) Act, 1980 for diversion of fresh forest area.
- ii) Name of the project reported as construction of retaining wall in various places of Polur-Jamunamarathur-Alangayam-Vaniyambadi road km 37/2 to 50/8.
- iii) The User Agency has applied the forest area diversion for 0.54 ha., and non forest land required for the project reported as Zero ha.,
- iv) The User Agency has proposed the forest area diversion for the project for a period of 99 years.
- v) On behalf of User Agency, Highways Department, Government of Tamil Nadu the Divisional Engineer, Highways, Construction and Maintenance, Tiruvannamalai Division has uploaded the proposal in the prescribed format. Legal status of the User Agency is State Government (Department).
- vi) The User Agency has uploaded a copy of autherisation issued by the District Collector, Tiruvannamalai District for furnishing online application for diversion of forest area for the project proposal.
- vii) Diversion of 0.54 ha of forest has been requested in Tiruvannamalai (South) Forest Division area in Tiruvannamalai District and Name of the village in which forest land requested has been reported as Chintahlur and Koottathur.
- viii) The User Agency has furnished the component wise breakup details of land required for the project as retaining wall.

In the area requirement statement for the project, the user agency has furnished the details of area required for various locations of forest area required for the work along with geo co-ordinates of the location. In total 23 number of retaining wall work along the road at various places have been proposed with forest area requirement of 0.54 ha

ix) Location map of the forest land proposed to be diverted in kml file of google earth, Scanned copy of Survey of India topo sheet marking the road runs through forest area and Scanned copy of Geo referenced location details of the forest land proposed to be diverted have been uploaded.

The user agency has uploaded kml file at various locations. In the area requirement statement, the user agency has indicated the retaining wall works

proposed at 23 locations with at which location, work proposed, length and width of area proposed etc., and geo co-ordinates of the location.

- x) Note containing justification for locating the project in forest area has been uploaded.
- xi) The User Agency has stated that this project is likely to generate permanent/regular employment for 150 persons and temporary establishment for 100 persons. This project does not involve displacement of people due to the project and cost-benefit analysis and Environment clearance for the project are not required.
- xii) The User Agency has reported that the project or part thereof is not located in any protected area or their Eco sensitive zone and this project or a part thereof is not located in a Scheduled area.
- xiii) The User Agency has uploaded a copy of certificate issued in ROC No. 232/JDO/2020, dated 10.07.2020 by the District Collector, Tiruvannamalai District on completion of the process for settlement of Rights under the Forest Rights Act 2006 on the forest land proposed to be diverted of 0.54 ha.
- xiv) The User Agency has not furnished the details of compensatory Afforestation land to be provided to the Forest Department in lieu of diversion of forest land required for the work and reason for this stated that not applicable.
- -- As per Forest (Conservation) Act, 1980, guidelines, compensatory afforestation may not be insisted for the forest area diversion up to 1 ha. In this project proposal forest area diversion proposed is 0.54 ha.
- xv) In the additional information details section, following documents/certificates/ undertakings have been uploaded.
- a) Certified that the construction of retaining wall in Polur-Jamunamarathur-Alangayam-Vaniyambadi is lying in Jamunamarathur Revenue village in Jamunamarathur Firka.
- b) Area breakup details of forest area requirement for chainage km 37/2 to 50/8 at various locations (23 sites) and certified that work is designed for minimum forest involvement.
- c) Certified that there is no suitable alternative non-forest land is available for the project for chainage km 37/2 to 50/8.
- d) Certified that no work in violation of the Forest Conservation Act 1980 will be carried out for forest land required for the project for chainage km 37/2 to 50/8

- e) Undertaking to pay the amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India for forest land required for the project for chainage km 37/2 to 50/8
- f) Undertaking to pay the additional amount of Net Present Value of forest land required for the project for chainage km 37/2 to 50/8
- g) Undertaking to deposit the cost towards raising and maintenance of compensatory afforestation scheme as per the scheme prepared by the State Government in lieu of forest land diverted for non-forestry purpose.
- h) Undertaking to pay the cost towards lease rent fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted for this project in for chainage km 37/2 to 50/8
- i) Certified that ten times of saplings cost would be paid towards number of trees proposed to be cut, which falls on the forest alignment in chainage km 37/2 to 50/8
- j) Undertaking to bear the cost of felling of trees and transportation cost of the trees likely to be removed, those available in the alignment path for the proposed diversion of forest land as fixed by the Forest Department.
- k) Certified that no work in violation of the provisions of the Forest (Conservation) Act, 1980 has been carried out in the project proposal area.
- l) The user agency has uploaded a copy of Forest Rights Act 2006 certificate issued by the District Collector of Tiruvannamalai District in Rc. No. Nil, dated Nil in the additional information details section for Chainage km 37/2 to 50/8 areas falls within the jurisdiction of Jamunamarathur Reserve Forest for 0.53 ha area.
- m) The user agency has uploaded certificate issued by the District Collector, Tiruvannamalai District in RC No. 232/2020/JDO, dated 10.07.2020 about No alternate non forest land is available for the project proposed in the forest area.
- n) The user agency has uploaded copy of orders obtained from the Government of Tamil Nadu in G.O. Ms No. 482, Environment and Forests (FRXI) Department, dated 12.07.1990 under Forest Conservation Act, 1980 for improvement of Ghat road from Polur to Top of Jawadhu hills and on to Alangayam in the erstwhile North Arcot District.
  - o) Revised area statement of retaining walls proposed in 23 locations
  - p) EDS reply on the area deviation.

- 3) The District Forest Officer, Tiruvannamalai Division has uploaded the proposal details in the Part-II of Form-A and forwarded the proposal to the Additional Principal Chief Conservator of Forests, Vellore Circle on 10.12.2020 and furnished the additional details called for by the Circle head in additional details called for section
- 4) In the Part-II of Form-A, the District Forest Officer, Tiruvannamalai Division has furnished following particulars.
- i) The legal status of the proposed sites of diversion of 0.47 ha of forest land requested for the project is Reserved Forests and as per site inspection report, name of the forest land is "Veerappanur and Palamarathur RFs" and extent of area proposed for diversion by the user agency is is 0.54 ha
- ii) The District Forest Officer has reported that, density of the forest area is 0.4 and Eco class of forest area is three.
- iii) As per species wise and girth class wise enumeration table segment furnished by the District Forest Officer, there is no tree growth is available in the proposed forest diversion areas.
- iv) On vulnerability of the forest land proposed for diversion, the District Forest Officer reported that there is no erosion in the forest area.
- v) The forest area proposed for diversion is not forms part of National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant corridor, Wildlife migration corridor etc., and not located within the eco-sensitive zone of the protected area notified under Wildlife (Protection) Act, 1972 and not located within 1 km boundary of NP/WLs etc., for the forest land proposed for diversion.
- vi) There is no rare/ endangered/ unique species of flora and fauna found in the area and details of wildlife present in and around the forest land proposed for diversion reported as NIL
- vii) There is no protected archaeological/ heritage site/ defense establishment or any other important monument is located in the area.
- viii) Requirement of forest land as proposed by the User Agency is unavoidable and bare minimum for the project and no work in violation of the Act or guidelines has been carried out.

- ix) For the diversion of 0.47 ha of forest land, the District Forest Officer has not proposed any compensatory afforestation scheme
- x) In the site inspection report, the District Forest Officer has reported the following.

The District Forest Officer has inspected the site on 20.10.2020 and 05.03.2021. Retaining wall will be constructed adjacent to the existing road of Polur-Jamunamarathur-Alangayam-Vaniyambadi road from km 37/2 to 50/8 of SH 215 of Jamunamarathur Range of Tiruvannamalai Division. The user agency has not yet started any work in the Reserved Forest area so far and there is no encroachment in the proposed area

The proposed forest land is of Southern Dry Deciduous forest type. The user agency has informed that there will be no felling of trees during the execution of the project and retaining wall will be constructed leaving out trees in the proposed areas without any serious impact on the surrounding forest area and it is very essential for the safety of the highways. Geo co-ordinates of the proposed construction sites have also been furnished.

xi) In the recommendation of the project proposal, the District Forest Officer has reported the following.

An area of 0.54 ha of forest land in Veerappanur RF and Palamarathur RF has been proposed for construction of retaining walls and the work is essential to ensure the safety and stability of the highways and will not be any felling of trees in the proposed area and hence the proposal recommended on public interest.

5) In the Essential Details called for section, based on the Additional Principal Chief Conservator of Forests queries, the District Forest Officer has furnished the revised site inspection report along with the statement on chainage site wise length and width of forest area involved and area required for the project.

In this construction of ten retaining walls cover an area of 1824 sq.m area lies in Veerappanur RF of Jamunamarathur Range and construction of eleven retaining walls covers an area of 2837 sq.m area lies in Palamarathur RF of Jamunamarathur Range.

- 6) The Chief Conservator of Forests and Additional Principal Chief Conservator of Forests, (FAC) Vellore Circle has inspected the area on 06.01.2021 and remarked that diversion of total area of 0.47 ha of forest land comprising 0.1824 ha in Veerappanur RF and 0.2837 ha in Palamarathur RF and further remarked that the retaining wall will be constructed adjacent to the existing road for safety of public and stability of the road. The user agency has stated that no existing trees will be disturbed and retaining wall will be constructed leaving the trees. This proposal has been recommended in public interest.
- 7) The District Forest Officer has recommended the proposal for 25 years and the Additional Principal Chief Conservator of Forests (FAC) has also recommended the forest area diversion for a period of 25 years.

Based on the recommendation of the District Forest Officer, Tiruvannamalai Division and Additional Principal Chief Conservator of Forests, Vellore Circle, diversion of forest area is recommended for a period of 25 years.

- 8) As recommended by the District Forest Officer, Tiruvannamalai Division and Additional Principal Chief Conservator of Forests (FAC), Vellore Circle, the proposal of diversion of 0.47 ha of forest area in Veerappanur RF and Palamarathur RF in Tiruvannamalai Forest Division for construction of 21 number of retaining walls in various places of Polur-Jamunamarathur-Alangayam-Vaniyambadi road from km 37/2 to 50/8 of SH-215) in Tiruvannamalai District in favour of Divisional Engineer, Highways Construction and Maintenance, Tiruvannamalai District may be recommended subject to the following conditions.
- a) The legal status of the diverted forest land remains unchanged.
- b) The demarcation of the proposed forest land shall be carried out by the User Agency by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at their cost.
- c) The User Agency has to pay the amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India.
- d) The User Agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by Forest Department in future.

- e) The User Agency has to pay the cost towards lease rent as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period.
- f) The total forest area utilized for the project shall not exceeds 0.47 ha
- g) Period of lease can be twenty five (25) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.
- 9) The proposal is sent herewith duly recommended by the Additional Principal Chief Conservator of Forests (Forest Conservation Act) / Nodal Officer, Forest (Conservation) Act, 1980 of the State of Tamil Nadu. I request that the proposal may be considered and Stage-I approval of Government may be issued for Palamarathur RF in Tiruvannamalai Forest Division for construction of 21 number of retaining walls in various places of Polur-Jamunamarathur-Alangayam-Vaniyambadi road from km 37/2 to 50/8 of SH-215) in Tiruvannamalai District in favour of Divisional Engineer, Highways Construction and Maintenance, Tiruvannamalai District Encl: As stated above.
