IPH-B(F) 5-13/2018 dated 22-10-2019 (RUDF-XXV) amounting to Rs. 3781.43 lac only under NABARD trench No. RIDF (XXV). The project is funded by National Agriculture Rural Development Bank. The construction period of the scheme is allowed for 24 months only with three months of defect liability period and three months of trail run. The work was awarded to the contractor/Firm vide this office letter No. JSV-JSVDJ-CB-Tender/2020-21 - 3919-29 dated 25-08-2020 amounting to Rs. 30,42,06,484/- only. According to EDs letter No. FC/HPB/02/38/2021 dated 24-08-2022. The

revised lay out plan of the Proposed scheme has been submitted/ up loaded on KML file.

point No. 1 (ii) to (vi)

There is no violation at site made by the user agency only the sites viz No. 1,2,3 has been leveled and removal of bushes/sapling have been done for stacking of material i.e. Sand, Aggregate, Stone, Tor steel etc. So that to comply the MoU condition made between user agency and NABARD.
