




PARTNERSHIP DEED

THIS DEED of partnership executed on this 9th day of August 1999 between:
Shri Amanjit Kaur W/o Sh. Narinderjit Singh aged 54 years resident of Hoshiarpur of the First part, Sh.
Aninderjit Singh S/o Sh. Narinderjit Singh aged 31 years resident of Hoshiarpur of the second part
and Sh. Chhavinderjit Singh S/o Sh. Narinderjit Singh aged 28 years resident of Hoshiarpur of the third
part, each of them hereinafter called the partners respectively.

WHEREAS the parties above have formed a partnership for ~~construction~~ of building comprising a Hall
and other adjoining rooms etc. for giving on Hire the Hall with adjoining rooms for marriages other
functions and exhibition under the name and style of M/S NAVJEET FARMS UNA ROAD,
HOSHIARPUR w.e.f. today 9th August 1999 and it is hereby desired by the parties to reduce into
writing the terms and conditions of the partnership verbally mutually settled so as to regular and control
the relations between them.

NOW THIS DEED OF WITNESSETH AS UNDER :

1. The partnership business will be carried on under the name and style of M/S NAVJEET FARMS
UNA ROAD, HOSHIARPUR.
 2.
 - a) Necessary capital as well as further funds required for the ~~purposes~~ of partnership business
shall be contributed or arranged by the partners in such manner as may be mutually
agreed upon by and between the partners from time to time. Interest @ 18% per annum
shall be payable to the partners on the amount outstanding to the credit of the account
of partners. Such interest shall be calculated and credited to the account of each partner
at the close of the financial year.
 - b) However in case of loss or lower income, rate of interest can be 'NIL' or lower than 18%
as may be agreed to by and between the partners from time to time.
- All the three parties have agreed to work in partnership firm as working partners. It is
hereby agreed that in consideration of working in the partnership, they shall be entitled to
salary at Rs. 3000/-/- per month.
However the partners shall be entitled to increase or reduce the above
Salary/Remuneration as may be mutually agreed upon by and between the partners from
time to time.
- Bank account or accounts will be maintained according to the needs of the firm which will be

7. The partnership shall be at 'WILL', terminable by any party's giving the other partners two month's notice, in writing, in advance.
8. Proper books of account will be maintained for all the transactions of the firm which will be open for inspection to all the partners.
9. No partner will be responsible for the personal debts of the other partners.
10. In case of any dispute amongst the partners, the same shall be referred to arbitration under the Indian Arbitration Act.
11. Any other matter not provided in this Deed will be decided by mutual consent of the partners.
