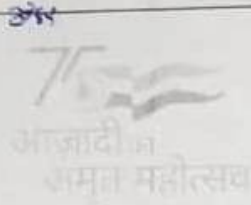

This has reference to your letter even dated 20.01.2022, in this regard, it is to intimate that the observations made by your good office, the point wise reply is as under:


1. In reply to point No. 01 it is submitted that, for making necessary corrections under A - 2 has been taken up with the NIC division of MOEF & CC, in this regard and necessary mail has already been sent.
2. In reply to point No. 02, it is submitted that the necessary corrections has been made under B - 2.2, B - 2.3 & B - 2.4 regarding total land in KML file.
3. In reply to point No. 03, regarding providing regular employment under E 9 (ii), it is submitted that the NHPC shall post regular staff 120 No's in phase wise manner before the commencement of the construction.

For making permanent Bench marks (PBM's), FRL, FRL -2, FRL -4 levels marking along the reservoir area on both the banks on ground and for enumeration of trees species wise etc falling in the submergence area were also carried during the joint survey with forest department Officials of Ramban division.

Further, as directed, in the meeting held on 16.02.2022 and joint survey conducted on 18.02.2022 for deputing survey team for carrying out the above work, it is to inform that a team of 3 Surveyors had already been deputed and the team has started the exercise of marking FRL levels on ground.
