1	In the FRA certificate the date of making of District Level Committee is 9.12.2014 were as the date of meeting of Sub Division Level Committee is 11.2.2015 which is not correct as DLC meeting has to be convened after SDLC meeting.	New FRA has been and uploaded on section K-(a) part I of form A. Hard copy of the same is being enclosed.
2	Muck Management Plan showing muck likely to be generated, proposed to be utilized has not been provided along with detail of dumping sites where the surplus muck is proposed to be dumped. Photographs of few dumping places are provided in hard copy without mentioning whether it is on private land or on forest land. May provide proper muck management plan showing detail of the dumping sites. In case the dumping sites are propose on forest land, area of the same may be added in the forest land proposed for diversion. In the case dumping of proposed in private land then detail of the owners along with detail of land and NOC from the owners may also be provided.	Muck disposal plan has been prepared showing the location and quantities of muck to be dumped. The muck disposal site have been choosen in private land for which the consent/NOC of land owner have been received . All the documents uploaded on additional section.

3	The number of trees mentioned on Part ii online, do not match with the dia class wise details provided on hard copy. For example, the number of trees of Pinus roxburghi above 90 cm dia has been mentioned as 01(one) while in online table it has been mentioned as 46. These anomalies may be corrected. The detail of no of trees given in hard copy and online Part ii should be exactly same in all respects.	This objection will be rectified at your end.
4	This suitability certificate of Land identified for CA is not opening online.	This suitability certificate of Land identified for CA have been re uploaded.
5	It is required to provide copy of proceedings of the concerned Gram Sabhas conveying that no rights are pending or all rights have been settled under FRA, 2006 in the forest area proposed for diversion. However, in the instant proposal proceedings of the meetings of Gram Panchayat /Gram Sabha provided with the FRA certificate mention only of having no objection to diversion of this land for the proposed road but do not convey anything on settlement of rights under FRA 2006	Required certificate or proceeding of concern Gram Sabha have been uploaded as Performa no- 23 on additional section. Hard copy attached.
