Subj: - Application for issue of NOC to diversion of the Forest Land.

Sir,

As the Application received vide letter No. 17628 dated 04.02.2021 from the Block Development Officer, Development Block Kullu vide which the applicant applied for NOC for diversion of 0-19-82 hectare forest land at Tukra No-1(II) situated near Sidhi Dhar, Village-Kasol, Gram Panchayat Kasol, Tehsil-Bhunter, Distt. Kullu-175105 (HP) for construction of solid waste Management Plant.

Therefore, H.P State Pollution Control Board has no objection only for diversion of above said land subject to the following conditions:-

1. The permission is only for diversion of above said land in favour of The Block Development Officer, Development Block Kullu, Distt. Kullu -175101(H.P).
2. This NOC shall only be under and for the purpose of diversion of the Forest land and shall in no way be used for the purpose of any mandatory clearances/MOEF, Govt. of India and permission required to be obtained by the proponent under any other law/provision.
3. The unit shall obtain Environment Clearance under EIA notification 2006 as applicable and consent of the State Board before undertaking any steps to establish the Solid Waste Management Plant under Water Act, 1974 and / or Air Act, 1981, as the case may be and unit has to take proper arrangement for disposal of muck, sewage and garbage as per guideline of Pollution Control Board.
4. Diversion of land shall be governed only by the regulations and provisions prescribed by Revenue Department and this NOC alone shall not entitle the applicant to purchase/acquire land.
5. NOC so issued shall not confer any right on the applicant to establish the project unless the Revenue department has actually allowed the acquisition of land.
