In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC (Pt.) dated 3rd August, 2009 wherein the MoEF issued Guidelines on submission of evidence for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 (FRA, for short) on the forest land Proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects, It is Certified that **14.294 Ha.** of forest land proposed to be diverted in favour of the Executive Engineer (R&B) NH Division Karimnagar for construction of Four Laning of NH-63 Nizamabad - Jagdalpur Road from Km 180/600 to 223/000 from Mancherial to Maharashtra State Border in the State of Telangana in Mancherial and Chennur Forest Divisions of Mancherial District and subsequent issue of certificate in Form-I as follows.
