Sub: Submission of Annual compliance report as on 31.03.2023 on the stipulated conditions in MoEF& CC, Gol, orders under F (C) Act for diversion of 161.31 Ha for renewal of GauthamKhani Opencast Project (Phase-I) for surface use in Bhadrakothagudem District-Kothagudem Division in favor of SCCL - Reg.

Ref: MoEF&CC, Gol letter No.F.No.8-117/2002-FC, Dt. 01.02.2010.

Kind attention is invited to the reference cited wherein the MOEF, GOI, has accorded final approval for diversion of Forest land to the extent of 161.31 H for GauthamKhaniOpencast Project Phase-I in Kothagudem. Accordingly, the Compliance report as on 31.03.2023 is submitted herewith on the stipulated conditions as in the order.

Condition No.(1): Legal Status of the forest land shall remain unchanged.

Compliance: Legal status of the land remains as Reserve Forest.

Condition No.(2): 100 Ha. of forest land proposed to be surrendered to the State Forest Department shall be done immediately with a compliance to the Central Government however, it should be maintained by the User Agency at their cost under the guidance of the Forest Department.

Compliance: The area of 100 Ha duly rehabilitated was surrendered to the Forest Department on 07.07.2010. This area is being maintained by the SCCL under the guidance of the Forest Department.

Condition No.(3)(a): All conditions mentioned in the earlier in principle approval shall be complied with.

Compliance: All the conditions were complied with and compliance report was submitted to Forest Department, which was forwarded to MoEF& CC by State Government.

Condition No.(3)(b): The non-forest land identified for raising Compensatory Afforestation shall be notified by the State Government as RF under Section-4 or PF under Section-29 of the Indian Forest Act, 1927 or under the relevant Section (s) of the local Forest Act, as the case may be, within a period of six months. The Nodal Officer (Forest Conservation) shall report compliance in this regard.

Compliance: Non-Forest land of 261.31 Ha forming part of 495.08 Ha at Rasannagudem was handed over to Forest Department on 06.03.1990. The SCCL has paid C.A. charges at the time of original diversion. The non-forest land was declared as protected Forest vide G.O.RT.No. 935, (For.VI-2) Dept., dated 05.12.1992.

Condition No.(4): Additional amount of the NPV of the diverted additional forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the user Agency. The User Agency shall furnish an undertaking to this effect.

Compliance: An undertaking to pay additional amount of NPV was furnished.

Condition No.(5): The forest land shall not be used for any purpose other than that specified in the proposal.

Compliance: The diverted forest land is being used for the purpose for which permission was granted.

Condition No.(6): The approval under the Forest (Conservation) Act, 1980 is subject to the clearance under the Environmental Protection Act, 1986.

Compliance: The SCCL has obtained Environmental clearance vide MoEF&CC, Gol, letter No.1).J-11015/46/89-IA-II(M), dated.13/01/1993, 2). J-20012/10/98-IA-II(M)pt dated 9/05/2001, 3) F.No.23-254/2018-IAIII(V), dated 20.05.2021.

Condition No.(7): The User Agency will make arrangement for free supply of coal to labourers and staff working on the project site so as to avoid any pressure on the adjacent forest areas.

Compliance: The SCCL is providing 12 Nos. LPG cylinders per annum per employee working in this project at free of cost.

Condition No.(8): The period of permission for lease under the Forest (Conservation) Act, 1980 will be for 20 years subject to possession of valid lease by User Agency under the MMDR Act, 1957.

Compliance: Yes, the lease period granted under MM(D&R) Act, 1957 is for 27 years and mining lease is valid up to 18.09.2034.

Condition No.(9): Demarcation of mining lease area will be done on the ground at project cost using four feet high reinforced cement concrete pillars with serial numbers, forward and back bearings and distance from pillar to pillar.

Compliance: The area has been demarcated with 4 feet height RCC pillars of 35 numbers have been fixed and the details are as mentioned.

Condition No.(10): Mining/reclamation schedule shall be implemented by the user agency at their cost as per Environmental Management Plan/ phased programme.

Compliance: Out of 261.31 Ha an area of 100 Ha after rehabilitation was surrendered to the Forest Department on 07.07.2010. This area is being maintained by the SCCL under the guidance of the Forest Department. In the remaining 161.31 Ha an area of 40.00 Ha is covered by service buildings which are required to be continued till the mining operations are carried out. In the balance area of 121.31 Ha, about 10.00 Ha area is back filled up to surface level and 111.31 Ha area is covered with Haulage roads, conveyor belt, transmission lines etc., which are being used for attending the mining operations in Phase-II & Phase-III land. The mining operations are going on as per EMP. Coal excavation was completed in the year August, 2019. Dumping of OB is under progress i.e. upto ground level 870RL (25.48Ha.). And as per approved VKCM mine closure plan 83.88Ha. Will be completed by the end of year 20th year (i.e.2043).

Condition No.(11): The User Agency shall also take up study on soil erosion/soil flow from the overburden areas with the help of GIS in consultation with the Forest department.

Compliance: The SCCL has provided 3.90 Km. toe wall and 9.60 Km., garland drains around the OB dump and 3 settling ponds and 2.60 Km. garland drains on decks. Measures have been taken to prevent soil wash (runaway of soil). All the garland drains are being de-silted regularly. Further, Species of plants planted in GKOCP Dendrocalamusstrictus, Hardwickiabinata Inga dulcii, Albeziaodoratissima, Ficusbenghalensis, Ficusrelegiosa, Semaroubaglauca,Ceibapentandra, Ficusmollis Aegle marmolose, Mytragynaparvifolia Dolichondrancrispa, Madhukalatifolia Terminaliabellarica, Eucalyptus clones etc. Agave suckers, Styloanthushamata & Saccharammunjaetc were planted for soil binding and prevention of erosion. Gabion structures and cribs were made to prevent further erosion from slopes. Stabilization of slopes & dump tops is being done immediately after completion of dump formation to prevent soil erosion. SCCL has carried out in-house soil erosion study. As per study

the soil loss is about 1.5 Tonnes /Ha, but this soil is stopped by the toe walls, garland drains and siltation ponds and not allowed to go out of lease area. The drains are regularly de-silted.

Condition No.(12): The User Agency shall take up the de-silting of the village tanks within 5 Km. radius from the mine lease boundary so as to mitigate the impact of siltation of such tanks whenever required.

Compliance: De-silting of village tanks such as Tungaram Tank in Tekulabanjara village and Penagadapa Tank was done. The SCCL has taken up construction of toe wall (3.90 Km), garland drains (9.60 Km) along the OB dump and 3 siltation ponds and garland drains (9.60 Km.) on decks in GK OC Project at the cost of Rs.1:02 crores and the maintain cost is Rs.0.12 crores per year.

Condition No.(13): Any other condition that the State Govt. or the Chief Conservator of Forests (Central), Regional Office, Bangalore may impose from time to time in the interest of conservation, protection or development of forests.

Compliance: SCCL Agree to abide with any other condition that the State Government or the Chief Conservator of Forests (Central), Regional Office, Bangalore(now Hyderabad) may impose from time to time in the interest of conservation, protection or development of forests.

Condition No.(14): All other conditions under different rules, regulations and guidelines including environ-mental clearance and forest rights of tribal and other forest dweller shall be complied with.

Compliance: All rules, regulations are being complied with. No rights under RoFR Act are recognized.

With reference to the letters cited, Stage-II clearance granted for diversion of 231.84Ha of forest land in Chathakonda Reserve Forest of Koyagudem Division in favor of Singareni Collieries Company Ltd. for Koyagudem Opencast mining operations.

Accordingly, SCCL hereby submitting the annual condition-wise compliance report as detailed below.

Condition (i): Legal status of the diverted forest land shall remain unchanged.

Compliance: Yes. Legal status of Forest land remained unchanged.

Condition (ii): Few indentified compensatory a forestation sites in degraded forest land was not suitable for plantations, accordingly, the regional office, Chennai was requested to inspect the site indentified for compensatory a forestation for the proposal and report the suitability of degraded forest land for compensatory a forestation and the regional office, Chennai, after DSS analysis and the Google maps along with site inspection, recommended that the moderately dense forest may be excluded for the planting of additional area in the compartment No. 311. Therefore, the total available area suitable for planting shall be as below.

Thus, the required compensatory afforestation of 464 Ha. from the suitable area of 479Ha as stated above in lieu of the forest land proposed to be diverted shall be raised within a period of three years with effect from the date of issue of Stage-II clearance and maintained thereafter in accordance with approved plan in consultation with the state forest department at the cost of user agency.

Compliance: Forest Divisional Officer, Paloncha identified degraded forest land of 464 Ha. (231.84x2) towards double the extent for CA in compartment Nos. 464, 293,307,310,311, and 312 of Dammapeta and Aswaraopeta Range,Paloncha Division. As per the demand issued by F.D.O Paloncha, SCCL deposited Rs.17, 04, 59,400/- into CAMPA account through RTGS in the SB Account No.037100101029963, IFSC CORP0000371, of Corporation Bank, New Delhi. An amount of **Rs.5,35,40,500/-** was remitted on 27.05.19 towards differential amount of CA charges for implementation of revised CA scheme for this diversion.

Condition (iii): Following activities shall be ensured by the state govt. as per approved plan at the project cost.

(a) *Appropriate mitigative measures to minimise soil erosion and choking of streams.*

Compliance:

1. Proper planning will be made for maintaining the slope of dump yard to control soil erosion.
2. The crest (top of slope) will be maintained with proper contour draining.
3. Vegetation cover will be developed around the surface, dumps and haul road dividers and berms.
4. Proper water management and water spraying on the benches and haul roads of quarry dump areas and coal stock yards etc. Is being done.
5. Bio- engineering structures will be planned according to development of quarry and dump operations.
6. Wet drilling arrangement is being provided.
7. Rock fill dams, check dams & settling ponds will be constructed & frequent de-silting of the same will be arranged to prevent choking of streams and drains around the quarry and dumps.

(b) *Planting of adequate drought hardy plant species and sowing of seeds in the appropriate area within the mining lease to arrest soil erosion.*

Compliance:

The following seedlings will be planted for control of soil erosion:

- i) Stylosanthus Hamates ii) Glyricidea iii) Red gram iv) Babul v) Subabul
- vi) Sesbania vii) Crotalaria juncea viii) Agave suckers soon after the formation of dumps.

(c) *Construction of check dams, retaining / toe walls along the contour to arrest sliding down of the excavated material*

Compliance:

- 1) Contour and garland drains on dump and in quarry areas are being done, Check dams for settling sedimentation will be arranged. The number of check dams constructed are 3.
- 2) To arrest the run of water and prevention of sediment deposits in the drains/streams, settling ponds and check dams are proposed for construction in addition to toe walls after formation of dump yards.

(d) *Stabilize the overburden dumps by appropriate grading / benching so as to ensure that angles of repose at any given place is less than 28.*

Compliance:

Dump stabilization is done with the help of dozer with grading/benching and also to ensure that over all angle of repose of over burden dump will be maintained less than 28 degrees and so on after formation of 30 mts deck in dump area.

(e) *Strict adherence to the prescribed top soil management*

Compliance: As per the approved EMP, top soil management will be done.

(e) *The user agency shall pay the additional amount of NPV, if so determined, as per the final description of the Hon'ble supreme court of India.*

Compliance: An Undertaking for payment of additional amount of NPV payable, if any, as per the Orders of Hon'ble Supreme Court is furnished.

Condition (IV): The user agency shall obtain the environment clearance as per the provisions of the environmental (protection) Act. 1986, before work for the project is initiated.

Compliance: SCCL has obtained Environment Clearance vide MoEF Ir No.J-11015/306/2006-IA-II (M), dtd. 11.06.2007.

Condition (v): The state govt. shall ensure the implementation of approved wildlife conservation plan to mitigate impact of project on kinnerasani wildlife

sanctuary and other habitats of wildlife located in and around the forest land proposed to be diverted at the cost of user agency`.

Compliance: Wildlife conservation plan was prepared by Local Forest authorities, Khammam Circle and approved by PCCF, Wildlife, and Telangana State. SCCL deposited 3259.997 lakhs into the account of Chief wild life warden and member secretary BIOSOT, Hyderabad through cheque bearing No: 182776 date 11.02.16, to mitigate the impact of project on kinnerasani wildlife sanctuary and other habitats of wildlife located in and around the forest land diverted.

Condition (VI): *The state govt. shall ensure that each family being displaced from the project site and settle on non-forest land to prevent illegal occupation / encroachment of the forest land by them. apart from taking other measures to achieve the said objective, as a measure to discourage the project affected families from encroachment on the forest land, payment of annuity for a period of atleast five years at the rate of the minimum wage payable to the unskilled person for 200 person-days per annum to each adult member of the project affected families, on receipt of a certificate signed by a forest officer not below the rank of a range officer having jurisdiction over the area where such person has settled after displacement from the project from the project site. in addition, the user agency shall track location of each displaced family and ensure that none of them encroach / occupy forest land. the state govt. shall implement the approved R &R plan for five years from date of taking possession of the forest land, the user agency shall submit an annual certificate to the principle chief conservator of forests, Telangana that none of the persons displaced from the project land has encroached / settled on the forest land during the year.*

Compliance: The user Agency (SCCL) deposited the funds of Rs 40,62,83,400 towards land compensation @ Rs 5,20,000 per acre and Rs 5,50,000 per PAF to the District Collector, Khammam through the cheques bearing Nos:38856 date 28.06.16,388409 dated18.06.16,388194 dated23.05.16 and 388587 date 05.07.16, as per the R&R scheme approved by the Commissioner, R&R, Govt of AP and disbursed the same towards land cost and R&R package through R.D.O.

Condition (vii): *The user agency in consultation with forest department shall erect chain-link fence of suitable gauge to a height of 2.0m around the safety zone area to prevent entry of the wildlife into the mining area.*

Compliance: Instead of chain link fencing, SCCL in consultation with local forest authorities, dug 2mX2m cattle proof trench around the total diverted area of the forest land.

Condition (viii): *The mined area (dugout pits) shall be refilled with fertile soil and bench terracing be done, if required, besides raising plantation with tall plants of native species at the cost of the user agency as a part of reclamation of the mined area.*

Compliance: The user agency (SCCL) removed the fertile soil and stacked separately and after the quarry area mined out it will be refilled with fertile soil and bench terracing be done, if required, besides raising plantation with tall plants of native species at the cost of the user agency as a part of reclamation of the mined area.

Condition (ix): *Boundary of the individual mines and safety zone is demarcated by erecting RCC pillars to avoid disputes among the lease holders as well as to check encroachment into adjoining forests.*

Compliance: RCC boundary pillars of 4 feet height have been constructed around the Forest area proposed for diversion. Serial Nos. forward and back bearings and distances from pillar to pillar are written on the pillars.

Condition (x): The state govt. ensure that the suitable bridges / quality roads shall be constructed at all low lying spots being frequently damage due to movement of lorries with heavy loads of coal at the cost of the user agency.

Compliance: User agency (SCCL) constructed 14 Nos Suitable bridges at all low lying spots and 6.32 Kms quality roads prepared out.

Condition (xi): User agency in consultation with the state forest department shall create and maintain alternate habitat / home for the avifauna, whose nesting trees are to be cleared in this project. Bird nests artificially made out of eco-friendly materials shall be used in the area, including forest area and human settlements, adjoining the forest area diverted for the projects.

Compliance: User agency (SCCL) in consultation with local forest officials prepared a scheme at a cost of Rs.3 lakhs to create and maintain alternative habitat/home for avifauna, whose nesting trees are to be cleared in this project in consultation with the State Forest Department.

Condition (xii): Fencing, protection and regeneration of the safety zone are (7.5 meters strip all along the outer boundary of the mining lease area as recommended by the state govt.) shall be done within three years at the project cost as per approved scheme. Besides this afforestation on degraded forest land to be selected measuring one & a half times the area under safety zone shall also be done at the project cost.

Compliance: Instead of chain link fencing, SCCL in consultation with local forest authorities, dug 2mX2m cattle proof trench around the total diverted area of the forest land. Regarding afforestation on degraded forest land measuring one & a half times the area under safety zone, SCCL deposited **Rs 18,92,400/-** into the CAMPA account through RTGS in the SB Account No.037100101029963, IFSC CORP0000371, of Corporation Bank, New Delhi.

Condition (xiii): *The period of diversion of the said forest land under this approval shall be for a period co-terminus with the period of the mining lease proposed to be granted under the mines and minerals (Development & regulating) Act. 1957, as amended of rules framed there under.*

Compliance: Yes. The period of lease under MM&DR Act is sanctioned for 20 years.

Condition (xiv): *The user agency in consultation with state forest department shall undertake gap planting and soil & moisture conservation activities to restock and rejuvenate the degraded open forests (having crown density less than 0.4), if any, located in the area within 100 mts. from outer perimeter of the mining lease.*

Compliance: SCCL will take up plantation in the 100 metres from the periphery of diverted land sooner after the land is handed over by Forest Department.

Condition (xv): *The state govt. and the user agency shall ensure de-silting of the village tanks and other water bodies located within five km from the mine lease boundary for which GPS coordinates given so as to mitigate the impact of siltation of such tanks / water bodies, whenever required, preferably within five years.*

Compliance: SCCL identified 2 village tanks within 5 kms from the lease area. Presently order placed for desilting of Tellavagu Cheruvu. Desilting of Tellavagu cheruvu is done. The total Desilted quantity was :44,648 M³

Condition (xvi): *The user agency shall undertake mining in a phased manner after taking due care for reclamation of the mined over area. The concurrent reclamation plan shall be executed by the user agency from the very first year, and an annual report on implementation there of shall be submitted to the nodal officer, forest (conservator) act. 1980, Government of Odisha and the Addl. Principal Chief conservator of forest (Central), ministry of environment & forests, regional office (south eastern zone), Chennai. If it is found from the annual report that the activities indicated in the concurrent reclamation plan are not being executed by the user agency, the nodal officer of the addl. Principal Chief Conservator of forests (Central) may direct that the mining activities shall remain suspended till such time, such reclamation activities are satisfactorily executed.*

Compliance: As per the approved EMP, reclamation starts at end of 6th year after opening the project and there after reclamation will be done in phased manner and an annual report on implementation there of will be submitted to the Nodal Officer, Forest (conservator) Act. 1980, State Government and the Addl. Principal Chief conservator of forest (Central), MoEF, Regional Office (South Eastern Zone), Chennai.

Condition (xvii): *The state govt. and the user agency shall ensure that no labour camp shall be established on the forest land.*

Compliance: Yes, no labour camps are established on the Forest land diverted.

Condition (xviii): The state govt. shall ensure that the user agency shall provide firewood preferably alternate fuel to the labourers and the staff working at the site so as to avoid any damage and pressure on the adjacent forest areas.

Compliance: SCCL is providing LPG at free of cost to all its employees @ 12 cylinders per annum and free coal as an alternate fuel to the labourers working at the site.

Condition (xix): The boundary of the mining lease and safety zone shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, forwarded and back bearing, distance from pillar to pillar and GPS co-ordinates.

Compliance: RCC boundary pillars of 4 feet height have been constructed around the Forest area diverted. Serial Nos. forward and back bearings and distances from pillar to pillar are written on the pillars.



Sub: Submission of status on compliance of the stipulated conditions in MoEF, GOI orders under F (C) Act for diversion of 124.00 Ha. for renewal of GauthamKhani Opencast Project (Phase-II) in Bhadrakothagudem District Kothagudem Division in favor of SCCL. Reg.

Ref: MoEF Letter No.8-17/98-FC, Dtd.08-02-1999.

Kind attention is invited to the reference cited wherein the MOEF, GOI, has accorded final approval for diversion of Forest land to the extent of 124 Ha for GauthamKhani Opencast Project Phase-II in Kothagudem. Accordingly, the Compliance report as on 31.03.2023 is submitted herewith on the stipulated conditions as in the order.

Condition No.(1): Legal status of the forest land shall remain unchanged.

Compliance: The legal status of land remains as Reserve Forest.

Condition No.(2): Compensatory Afforestation shall be raised over equivalent non-forest land at the project cost.

Compliance: The SCCL has handed over non-forest land of 124 Ha to the Forest Department on 06-03-1990 towards CA. This land is part of 495.08 Ha situated in Sy.No.116 of Rasannagudem (V) , Mulakalapalli (M), Paloncha Forest Division and handed over to the Forest Department. The SCCL has paid Rs.49,60,000 to the Divisional Forest Officer, Paloncha on 23-11-1998 towards CA charges. The SCCL paid cost of CA (124.00 Ha.) amounting to Rs.49,60,000/- vide Cheque No.32932, dtd.23.11.1998. Further, the State Government vide letter No.15050/For.I/97-7, dtd.08-01-1999, confirmed the above CA land, while forwarding the proposal to MoEF, Gol.

Due to high density of tree growth in the area (NFL) already handed over to Forest Dept., alternate degraded Forest land of 124.00 Ha., suitable for raising plantation was

identified in Compt.No.7 of Kondapur Block, Aswapuram Range, Paloncha Division. Accordingly, a Certificate dtd.8-10-1998 is also issued regarding its suitability for raising Compensatory Afforestation by FDO, Paloncha.

The MoEF&CC, Gol vide Lr.No.8-17/1998 FC (Vol), dt.01.05.2023 has informed that 61.66 ha.0 is overlapping of CA area of SRLIP and 81.04 ha under encroachment. The SCCL has handed over the said CA land free from encroachment. However at this stage submitting herewith an under taking to handover 124 ha of Non-forest land (from their land bank) at Rasannagudem village, Mulakalpalli Mandal, Erstwhile Khammam District handed over to Forest Dept vide Charge Certificate on 06.03.1990, the SCCL also paid CA charges Rs.49,60,000/- on 23-11-1998.

The Forest Divisional Officer, Mulugu informed the this land has good forest growth and fenced. The SCCL will handed over the land after grant of Stage-I.

Condition No.(3): Demarcation of mining lease area will be done on the ground with RCC pillars with serial number and bearing and distance from pillar to pillar at the project cost.

Compliance: Since the mining lease area is for the quarry purpose, accordingly demarcation with pillars has been made in field. The entire area of 124.00Ha has been de-coaled all the pillars are disturbed in the Opencast mining. In the area filled with OB 14 nos. pillars had been constructed.

Condition No.(4): The non-forest land transferred to Forest Department for Compensatory Afforestation shall be declared protected forest/ reserved forest under Indian Forest Act, 1927.

Compliance: The SCCL has already handed over the Non-forest land measuring 124.00 Ha. in Rasannagudem (V) to the Divisional Forest Officer, Paloncha on 06.03.1990. This area forms part of total area measuring 495.08 Ha. of Non-Forest land in Sy.No.116 of Rasannagudem (V) of Mulkalapally Mandal, which was handed over to Forest Department towards CA land for various projects of SCCL. At the time of handing over the land, Charge/ Mutation Certificate Rc.No.B/912/97, dtd.07.07.1991, and Certificate of Non-encumbrance dtd.6-02-1990 issued by the Mandal Revenue Officer were also submitted to the Divisional Forest Officer, Paloncha.

Condition No.(5): The User Agency will transfer funds for fencing, protection, regeneration of safety zone area and also the cost of afforestation over one and half time of the safety zone area degraded elsewhere in favour of Forest Department

Compliance: An amount of Rs.3.66 lakhs was paid to Divisional Forest Officer, Kothagudem on 23.11.1998 towards plantations in safety zone area and afforestation in 1½ times of safety zone area. Safety Zone area for 124Ha. cannot be maintained due to the area is in the middle of the Quarry. However Safety Zone area is maintained around the project.

Condition No.(6): Reclamation of mined area will be done as per the approved plan at the cost of User Agency. Soil conservation and afforestation work around OB dump area should be carried out to control soil erosion from that area.

Compliance: The entire area is taken for quarry purpose. Now this area is proposed for dumping of OB from the proposed VK OC (VenkteshKhani OCP) and accordingly revised Mining Plan got approved from the MOC vide reference No.38077/12/2017-PCA, dt.12.09.2019. The reclamation of mined area will be taken up as per revised approved mining plan. Soil conservation and afforestation works are taken up on the OB and about 504.50 Ha. of OB dump area has been planted and it is coming up well. The total forest land is 540.27Ha. as on today at about 270.45Ha. Plantation was done. 201.89Ha. Plantation will be damaged for VKCM dumping operation and Plantation

(83.98Ha.) will be done 10th Year (i.e.2033) Up to 930RL as per mining plan. Thus the total plantation in GKOC will be 738.3Ha. by the end of year 20th year (i.e.2043).

Condition No.(7): OB dump and mined out area of Phase-I will be reclaimed by the user agency within next one year and plantation will be taken up and report in this regard will be submitted to this office and Regional Office at Bangalore.

Compliance: SCCL vide letter No. GMK/ASO(SUR)/ 61A/2K/96 dated 11.04.2000 requested GOI for deletion of condition (7), as it is not in consonance with condition No.6 and the GOI vide letter No. 8-17/98-FC, dated 01.01.2002 amended and communicated the same to read as " in a phased manner as per approved Reclamation Plan" instead of within next (1) year. The reclamation is being done as per approved EMP. A Half yearly Environmental Monitoring report is regularly submitted to The Director, Regional Office, MoEF&CC Hyderabad. The recent report (April-2022 to September-2022) was submitted vide Lr.No.KGM/ENV/401/160, dtd 26.11.2022. Coal excavation was completed in the year March,2019. Dumping of OB in under progress and 83.98Ha. Up to 930RL by end of year 10th Year (i.e.2033). and balance 40.02Ha. Will be completed by the end of year 20th year (i.e.2043). as per approved VKCM mine closure plan.

Condition No.(8): The lease period will be for 20 years.

Compliance: The lease period is for 20 years. The renewal proposal was submitted well in advance on 28-03-2018 by SCCL and State Government vide letter No.1069/For.I/2019, dtd.29-10-2019 has forwarded the proposal to MoEF&CC, GoI, recommending for renewal. Mining Lease under MMDr Act is valid upto 26.04.2029.

Condition No.(9): The user agency will provide free fuel wood to labour and staff working at the project site so as to avoid any pressure on adjoining forest land.

Compliance: The SCCL is providing LPG to all its employees at free of cost @ 12 cylinders per annum.

Condition No.(10): Proper drainage pattern should be provided and maintained in the project area.

Compliance: The total diverted area was meant for Mining (Quarry) operations. The total drainage over the surface was broken up and the water flowing on the surface was impounded in void. There was no major/minor stream over the surface. There is no damage to the overall area of the mine. This diverted area is continues to the earlier diversions.

Condition No.(11): The SCCL should not burn on coal at the project site as well as project for manufacturing soft cake or household cake.

Compliance: Coal burning is not taking place in SCCL for making soft coal.

Condition No.(12): This approval is subject to Environment Clearance under Environment (Protection) Act.

Compliance: MoEF vide letter No.23-254/2018-IA.III (V), dt.20.05.2021 and accorded Environmental Clearance.

Condition No.(13): Any other condition that the State Government may impose from time to time for the protection and improvement of flora and fauna in the forest area.

Compliance: No other condition was stipulated. The SCCL will abide with any condition if imposed in future.

Sub: Submission of Annual compliance report as on 31.03.2023 for the stipulated conditions in MoEF& CC, GOI orders under F(C) Act for diversion of 154.96 Ha. for Gautham Khani Opencast Project (Phase-III) in Bhadravati Kothagudem District-Kothagudem Division in favor of SCCL-Reg.

Ref: MoEF&CC, GOI letter No.F.No.8-62/20050-FC, Dt. 09/07.2008.

Kind attention is invited to the reference cited wherein the MOEF, GOI, has accorded final approval for diversion of Forest land to the extent of 154.96 for Gautham Khani Opencast Project in Kothagudem. Accordingly, the compliance report as on 31.03.2023 is submitted herewith on the stipulated conditions as in the order.

Condition No.(1): Legal status of the forest land shall remain unchanged.

Compliance: Legal status of land remains as Reserve Forest.

Condition No.(2)(i): Compensatory Afforestation shall be raised and maintained by the State Forest Department at the project cost.

Compliance: CA land was identified in Sy. No. CB of Mulapet (V), Ranasthalam (Mandal), by the SCCL and handed over to Forest Department, Srikakulam Forest Division. An amount of Rs.82,08,000 was deposited vide DD Nos. 49419 to 49426, dtd.18-4-2008 towards CA charges.

Condition No.(2)(ii): Fencing, protection and regeneration of the safety zone area (7.5 meters strip all along the outer boundary of the mining lease area) shall and a half times the area under safety zone, shall be done at the project cost. Besides this, afforestation on 100 meter radius of mining lease granted in degraded forest land if density is less than 0.4/enrichment plantation shall be taken up by the user agency in consultation with the Forest Department.

Compliance: The SCCL has deposited Rs. 2.890 lakhs towards 1½ times safety zone, Rs.7.690 lakhs towards fencing of safety zone area and Rs.0.220 lakhs towards regeneration of safety zone area with DFO, Kothagudem on 14-09-2006

vide Cheque No.239739 of SBH, Rudrampur. Maintained the Safety zone of 7.5mtrs. is inside this area of 154.96Ha.

Regarding planting in 100 M radius from the Mining Lease periphery, the Forest Range Officer, Ramavaram has identified availability of degraded forest land of 6.00 Ha. within 100 meters radius where density is less than 0.4. This area was planted during 2016 planting season.

Planting all around in 100m could not be done as this diversion is surrounded by Mine (Quarry) and Non-forest in 3 sides.

Condition No.(2)(iii): Where ever possible and technically feasible, the User Agency shall undertake afforestation measures in the blanks within the lease area, as well as along the roads outside the lease area diverted under this approval, in consultation with the State Forest department at the project cost.

Compliance: Since the forest land diverted was for OC mining, it was not possible to take up plantation in the area during mining operations. The area will be planted only after completion of mining and re-filling with OB as per EMP. The SCCL has taken up avenue plantation in its area is 2.00 Ha.

Condition No.(3): The recommendations made in the Impact Assessment Study carried out by Indian Council of Forestry Research and Education(ICFRE) shall be implemented at the project cost.

Compliance: As per the recommendations made ICFRE, suitable compliances including sprinkling of water along the haul roads, removal of used oil barrels, de-silting of tanks, plantation etc.. have been made. Till now around 8.30 crores have been utilized for remediation & NCRAP for GKOPC.

Condition No.(4): The scheme for soil and moisture conservation for the entire watershed area shall be implemented at the project cost.

Compliance: The SCCL has taken up construction of toe wall (3.90 Km), garland drains (9.60 Km) along the OB dump and 3 siltation ponds, 8 cribs, 8 Rock fill dams in GKOC Project at the cost of Rs.1.30 crores. Agave suckers, Saccharum munja & vetivers were planted for soil binding and prevention of erosion. Broadcasting of Stylosantheshamata was also done which prevented the soil erosion as well as improved nutrient status.

Condition No.(5): The non-forest land proposed for compensatory afforestation should be transferred and mutated in the name of Forest department and should be declared as Reserve Forests.

Compliance: 154.96 Ha. of non-forest land identified in Sy.No. CB of Mulapet (V), Ranasthalam (M) of Srikakulam Division was handed over and mutated in favour of Forest Department on 30-01-2001, Srikakulam Division.

Condition No.(6): All measures should be taken to prevent pollution of tanks, rivers and nalas, etc. The desilting of adjoining villages in radius of 5 Kms may also be taken up by the User agency from time to time.

Compliance: De-silting of village tanks such as Tungaram tank in tekulabanjara village and Penagadapa Tank was done.

Condition No.(7): The period of diversion under this approval shall be twenty (20) years subject to possession of valid lease by the User Agency under the MMDR Act, 1957.

Compliance: Yes, the lease period will be 20 years.

Condition No.(8)(I): The User Agency shall take up Planting work on the static dumps during the advance mining operations and the toe wall around the dump shall be taken up by the user agency.

Compliance: Planting work on the static dumps was taken up in a phased manner as per the EMP and so far about 504.50Ha. (Out of 154.96 Ha.) of OB dump area has been reforested with miscellaneous species and they are coming up well. Toe wall of 3.9Kms was already constructed along the dump toe.

Condition No.(8)(II): All the dumps shall be fully reclaimed by afforestation immediately after closure of the mine in the shortest possible period under supervision of the State Forest Department.

Compliance: This will be complied with after completion of mining.

Condition No.(9): Any tree felling shall be done only when it is absolutely necessary and unavoidable, and shall be carried out under strict supervision of the State Forest Department.

Compliance: Since the area diverted was for OC mining, it was handed over by the Forest Department after extraction of tree growth.

Condition No.(10): No damage to the flora and fauna of the area shall be caused.

Compliance: SCCL is not causing any damage to flora and fauna in the adjoining forest land. A good plantation in 538 Ha. (forest & non-forest land) raised in GKOC providing shelter to fauna even from adjacent areas. Miscellaneous species planted are coming up well and providing shelter to fauna.

Condition No.(11): For reclamation works, the top soil should be preserved and should be used for reclamation. The areas shall be reclaimed keeping in view the international practice of stabilizing the dumps by grading / benching so that angles of repose (normally less than 28° at any given place) are maintained.

Compliance: Top soil management is being followed as per approved EMP. So far, top soil spread over OB dump is 3.40Mcum Balance Top soil 1.60Mcum preserved in 880RL deck will be used for reclamation of VKCM OB dump yards As per approved plan of VKCM, OB dump yards. Fresh OB will be dumped in GKOC void area.

Condition No.(12): The reclamation plan including siltation tanks shall be implemented and monitored continuously. The User Agency should furnish the extent of area to be technically and biologically reclaimed each year, to facilitate monitoring. The annual report about the progress of reclamation should be submitted to the Chief Conservator of Forests, Regional Office, Bangalore.

Compliance: The SCCL has taken up plantation total - 538.00Ha. (External Dump yard 395.00 Ha. & Int. Dump Yard 109.5 Ha.). Reclamation was started in 1999, every year technically and biologically reclaimed up to the year of 2018.

The last compliance report was submitted to the MoEF&CC, vide Lr.No.KGM/ENV/401/83, Dt.26.05.2022 for the period ending March, 2022. The species planted in GK OCP are *Dendrocalamusstrictus*, *Hardwickia binata* *Inga dulcii*, *Albeziaodoratissima*, *Ficus benghalensis*, *Ficus religiosa*, *Semarouba glauca*, *Ceiba pentandra*, *Ficus mollis* *Aegle marmolose*, *Mytragynaparvifolia* *Dolichondrancrispa*, *Madhuka latifolia* *Terminaliabellarica*, *Eucalyptus* clones etc.

Condition No.(13): It shall be ensured that no labour-camps are set up inside the forest area.

Compliance: No labour camp is there in Reserve Forest.

Condition No.(14): The mining lease area shall be demarcated on ground at the project cost, using four feet high RCC pillars, with each pillar inscribed with the serial number, forward and backward bearings and distance between two adjacent pillars.

Compliance: The area has been demarcated with 4 feet height RCC pillars. And 42 numbers of pillars have been fixed details are mentioned. (KML file enclosed).

Condition No.(3): The compensatory afforestation shall be raised over 11.96 Ha. of identified non-forest land at Sy. No.111 and 284 of Indaram Village, Jaipur Mandal, Mancherial Forest Division at the cost of user agency. The State Government shall obtain prior permission of Central Government for change of location and schedule of compensatory afforestation site, if any.

Compliance: SCCL has deposited an amount of Rs.8,80,500/- towards CA charges with the Divisional Forest Officer, Mancherial through DD No.139635, dtd.28-4-2005 of SBH, Mancherial.

Condition No.(4): The non-forest land for compensatory afforestation shall be notified by the State Government as RF under Section 4 of PF under section 29 of the Indian Forest Act, 1927 or the State Forest Act within a period of 6 months and the Nodal Officer (Forest Conservation) shall report the compliance within 6 months.

Compliance: 11.96 Ha. of non-forest land identified in Sy.No.111 and 284 of Indaram (V) in Jaipur (M) in Mancherial Division has been handed over and mutated in favour of Forest Dept. Status of Notification to be furnished by Forest Dept.

Condition No.(5): The mining activity in forest area shall be carried out as per the approved Mining Plan from the IBM.

Compliance: This approval was for re-alignment of Nallah (Stream) and work has been completed as per plan. The mining activities in underground mine are being taken up as per approved mining plan.

Condition No.(6): The consent of State Pollution Control Board shall be obtained under Air and Water Act before commencement of mining operation and it shall be renewed every year.

Compliance: It is for re-alignment of Tellavagu Nallah for safe working of VK 7 underground mine for which Consent For Operation (CFO) was obtained from TSPCB vide Ref.No.17082598755, dt.22.3.2017.

Condition No.(7): No other structure shall be constructed in the leased forest area.

Compliance : No structure has been constructed in this area.

Condition No.(8): The forest land to be used for the project shall not exceed 11.96 Ha. In case the land is not utilised for the stipulated purpose, then the area will be resumed by the Forest Department.

Compliance: The land has been utilized to the extent of 11.96 Ha for the purpose for which approval was obtained.

Condition No.(9): The Environmental clearance shall be obtained from Ministry of Environment & Forests as per the EIA Notification dated 27.01.1994.

Compliance: It is an operating mine without Environmental Clearance and the proposal is sent to MoEF&CC for obtaining EC for regularization. It is applied as for MoEF&CC notification vide SO.No.804(E) dated:14-03-2017 and the proposal number is IA/TG/CMIN/65213/2017. Environmental Clearance was obtained as per EIA Notification 2006 Vide EC Letter No. F.NO.23-73/2018-IA.III(V), Dt.07.06.2021.

Condition No.(10): All precautionary measures as suggested in the Environmental Impact Assessment report of ICFRE shall be carried on by the project authority at the appropriate timings to avoid any negative impact.

Compliance: All the suggestions of ICFRE is being implemented after receiving necessary instructions from Forest Divisional Officer, Kothagudem. Monitoring of changes in flora and fauna in the reserved forest due to realignment of Tellavagu Nallah was entrusted to ICFRE, Hyderabad. The MoU, preliminary report, first six monthly, second six monthly report, first annual report, third six monthly report and fourth six monthly report submitted by ICFRE were sent to Divisional Forest Officer, Kothagudem. The second annual report, fifth six monthly report, sixth six monthly report and project completion report (PCR) of ICFRE sent to Forest Divisional Officer, Kothagudem.

Condition No.10(a): Top soil from the diversion area shall be spread over as top layer in the filling area and shall be planted with native species in order to minimize disturbance to the flora and fauna.

Compliance: Top soil was spread as stipulated and miscellaneous & local plant species were planted and they have established well.

Condition No.10(b): The cross sectional dimension of the proposed diversion Nallah shall be decided after considering the maximum rainfall and topography of the area for free flow of water to avoid water logging and consequent disturbance of the local flora and fauna.

Compliance: The Nallah depth/crossing sections are maintained according to requirements/ topography and there is no damage to flora and fauna.

Condition No.(10)(c): The side slopes of proposed diversion Nallah should be decided after considering the geology and soil of the area, construction of engineering structures at suitable points useful for water retention for animals and birds shall be taken up by the project proponent.

Compliance: As per technical requirement and feasibility, side slopes of the Nallah were decided and now maintained. 2 Nos. of check dams were constructed and they are serving as water pool to the local fauna.

Condition No.(10)(d): Prior to the realignment of Nallah, conservation strategy to native species, management of top soil, measures to prevent soil erosion shall strictly be followed as suggested in the study report.

Compliance: As suggested, due care was taken for conservation of soil.

Condition No.(10)(e): M/s. SCCL shall allocate funds for undertaking monitoring change in flora and fauna at six monthly interval or a period of three consecutive years due to shifting of Nallah.

Compliance: In house study was carried out by Environment and Forestry wing of the SCCL. It indicates improvement in the area by means of flora and fauna.

Condition No.(11): The user agency shall deposit the Net Present Value (NPV) of the diverted forest area measuring 11.96 Ha. with the State Forest Department as per the orders of the Hon'ble Supreme Court dated 30.10.2002 and 01.08.2003 in I.A. No. 566 in W.P.(C)No. 202/95 and the guidelines issued by Ministry vide letter No. 5-1/1998-FC(Pt.II) dated 18.09.2003 and 22.09.2003 in this regard.


Compliance: An amount of Rs.82,55,600 was deposited towards NPV with the Divisional Forest Officer, Kothagudem vide Cheque No.725889, Dt. 28.04.2005 of SBH, Kothagudem.

Condition No.(12): All the funds received from the user agency under the project shall be transferred to the Competency Afforestation Fund Management and Planning Authority (CAMPA). Till such time an appropriate Head of Account is communicated in this regard, such funds shall be kept in the form of fixed deposits in the name of the concerned Divisional Forest Officer or the Nodal Officer in any Nationalized Bank as per the guidelines issued by the Ministry of Environment & Forests dated 22.03.2004. The State Government shall utilize all the funds other than NPV till a direction is given by the Central Government in respect of NPV of the diverted forest land.

Compliance: The money received has been transferred as stipulated.



Ref: GOI (MoEF) Lr.No.8-277/85-FC, dtd.17.02.2009.

Kind attention is invited to the reference cited wherein the MOEF, GOI, has accorded final approval for renewal of diversion of Forest land to the extent of 1174.18Ha for UG in Kothagudem. Accordingly, the compliance report as on 31.03.2023 is submitted herewith on the stipulated conditions as in the order.

Condition No.(1): Legal status of the forest land shall remain unchanged.

Compliance: The legal status of the land remains as Reserve Forest.

Condition No.(2): The State Government shall charge the Net Present Value (NPV) for the forest area proposed for renewal to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30.10.2002, 01.08.2003 and 09.05.2008 in I.A. No.566 in WP(C) No. 202/1995 and as per the guidelines issued by this Ministry vide letters No. 5-1/1998-FC (Pt.II), dated 18.09.2003, as well as letter No. 5-2/2006-FC, dated 03.10.2006 in this regard.

Compliance: As per the demand notice issued by Divisional Forest Officer, Kothagudem, the SCCL has deposited Rs.36,75,18,340 through DD No. 713038, dated 18.05.2009 in favor of CAMPA A/c. No.CA-1578, Corporation Bank, New Delhi.

Condition No.(3): Additional amount of the NPV of the diverted additional forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.

Compliance: An Undertaking for payment of additional NPV as and when asked for was furnished by SCCL.

Condition No.(4): All the funds received from the User Agency under the project shall be transferred to in Account No. 344901010070128 of Union Bank of India, Sunder Nagar, New Delhi-110 003.

Compliance: The Forest Department has complied with this condition.

Condition No.(5): Wherever possible and technically feasible, the User Agency shall undertake afforestation measures in the blanks within the lease area as well as within 100 Meter radius from the lease area inside RF, if density is lesser than 0.4 and maintain it till the life of the project, in consultation with the State Forest Department.

Compliance: The Divisional Forest Officer, Kothagudem vide reference No.4040/07/A5, dt.09.06.2015, permitted SCCL to take up plantation in the degraded patches within Kothagudem Mining lease as per the work plan submitted by SCCL. Accordingly, SCCL raised plantation in the area of 95.00 Ha. (to the extent of gaps available) in the degraded patches within 1174.18 Ha. in phased manner. An area of 15.00 Ha was also raised plantation within 100Mtrs radius from the periphery of 1174.18 Ha. The SCCL is herewith submitting an undertaking to take up plantation elsewhere in equal extent of plantation raised at the cost of UA.

Condition No.(6): The User Agency shall raise and maintain the Afforestation including enrichment plantation over surface area.

Compliance: As submitted in Sl.No.5.

Condition No.(7): The period of diversion under this approval shall be twenty (20) years subject to possession of valid lease by the User Agency under the MMDR Act, 1957 so that it shall be co-terminus.

Compliance: The period of lease is for 20 years.

Condition No.(8): Any tree felling shall be done only when it is absolutely necessary and unavoidable.

Compliance: As the area is for underground mining, no tree felling was required for mining.

Condition No.(9): No damage to the flora and fauna of the area shall be caused.

Compliance: Since the lease is for underground mining, there will be no damage to the Flora and Fauna by mining operation.

Condition No.(10): Reclamation Plan shall be strictly implemented which shall be monitored regularly by the State Forest Department/ Regional Office, Bangalore.

Compliance: The SCCL is operating two UG mines namely Padmavathi khani no.5 Incline (789.78 ha.) and Venkatesh khani no.7 Incline (384.40 ha.) in 1174 Ha. For both the mines individual mining plans have been approved by MoC, Gol vide reference no. 13016/4/2007-CA II, Dt.27.07.2016 and 13016/32/88-CA, dt.27.07.1988 respectively. In the UG mining reclamation is only closing of UG mine by salving of material for UG Mine and closing Mine entries. However, 237.8589 ha. area of VK-7 Incline & 411.4445 ha. area of PVK-5 Incline has been included in the Mining plans of Venkatesh khani Opencast Project. The MoC, Gol approved Mining Plan of Venkatesh khani opencast Project (Amalgamation of PVK-5, VK-7 & GKOPC) vide Lr.No.38011/12/2017-PCA, Dt.27.01.2020 and accordingly Mine Closure will be done at the end of the Venkatesh Khani Opencast Project.

Condition No.(11): It shall be ensured that no labour camps are set up inside the forest area.

Compliance: No labour camps are set up inside the sanctioned forest land.

Condition No.(12): The mining lease area shall be demarcated on ground at the project cost, using four feet high RCC pillars, with each pillar inscribed with the serial number, towards and backward bearings and distance between two adjacent pillars.

Compliance: The mining lease area is demarcated on ground by using RCC pillars of 4 feet height 39 Numbers of pillars have been fixed, details are follows:

Condition No.(13): The User Agency shall take up the de-silting of the village tanks within five KM area from the mine lease boundary so as to mitigate the impact of siltation of such tanks whenever required.

Compliance: As it is an underground mining, question of soil erosion due to mining activity does not arise. However, SCCL has taken up desilting in Tungaram Tank of Tekulabanjara and Penagadapa Tank at the cost of Rs.1.02 crores, the silted soil was taken over by the local farmers to their fields. (Enclosed as Annexure-1).

Condition No.(14): The forest land shall not be used for any purpose other than that specified in the proposal.

Compliance: The land is being used for the purpose only for which permission was obtained.

Condition No.(15): Any other condition that the CCF (Central), Regional Office, Bangalore/ State Government may impose from time to time for protection and improvement of flora and fauna in the forest area, shall also be application.

Compliance: It is further brought to the kind notice that this area was diverted for UG purpose. Basing on the faults etc the area was worked under two mines namely VK-7 UG mine 338.81 and PVK-5 UG 787.89 ha. and the balance is outside the mine boundary, according to which mines are being operated.

Kind attention is invited to the reference cited. The Annual status of Compliance of stipulated conditions under F(C) Act is furnished below.

Condition No.(1). Legal status of the diverted forest land shall remain unchanged.

Compliance: Legal status of the forest land remained unchanged.

Condition No.(2) The User Agency shall pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India and transfer the same to the ad-hoc CAMPA under intimation to this Ministry.

Compliance: An Undertaking for payment of additional amount of NPV payable if any as per the orders of Hon'ble Supreme Court of India is furnished to MoEF&CC

Condition No.(3). The State Govt. and the user agency shall ensure that the forest land on surface of the mining lease may fenced and afforested by the user agency.

Compliance:

Condition No.(4). The period of diversion of the said forest land under this approval shall be for a period co-terminus with the period of the mining lease proposed to be granted under the Mines and Minerals (Development & Regulating) Act, 1957 as amended or rules framed there under.

Compliance: Yes, lease is granted for 20 years under M&M (D&R) Act.

Condition No.(5). The User Agency in consultation with State Forest Department shall undertake gap planting and soil & moisture conservation activities to restock and rejuvenate the degraded open forests (having crown density less than 0.4), if any, located in the area within 100m from outer perimeter of the mining lease.

Compliance: The area of 100 Mtrs., from outer periphery has been Inspected. No gaps are found to take up gap plantation, since the area is covered with dense growth.

Condition No.(6). The State Govt. and the User Agency shall ensure de-silting of the village tanks and other water bodies located within five km from the mine lease boundary so as to mitigate the impact of siltation of such tanks/water bodies, whenever required preferably within five years.

Compliance: De-silting of village tanks such as Tungaram Tank in Tekulabanjara village and Penagadapa Tank was done. Further, process of desiltation will be taken up subsequently for other Tanks identified.

Condition No.(7) The State Govt shall ensure that the user Agency shall provide firewood preferably alternate fuel to the labourers and the staff working at the site so as to avoid any damage and pressure on the adjacent forest areas.

Compliance: SCCL is providing free supply of LPG to all its employees @ 12 cylinders per annum.

Condition No.(8). The State Govt. shall ensure that the forest land shall not be used for any purpose other than that specified in the proposal and under no circumstances be transferred to any other agency, department or person without obtaining prior approval of the Central Government.

Compliance: The forest land proposed to be diverted will not be transferred to any other agencies, department or person without prior approval of Central Government.

Condition No.(9). The User Agency shall restrict the felling of trees to minimum numbers in the diverted forest land and trees shall be felled under strict supervision of the State Forest Department.

Compliance: Since the sanctioned forest land is for installation of submersible pumps, approach road, transmission lines etc., the trees were cleared by Forest Department and handed over to SCCL.

Condition No.(10). The layout plan of the proposal shall not be changed without prior approval of the Central Government.

Compliance: Yes. The layout of the proposed forest land will not be changed without prior approval from the Central Government.

Condition No.(11). No labour camps shall be set up inside the forest area. Labour management plan should be implement with emphasis that no labour camp be set up in the close vicinity of the eco-fragile and sensitive areas.

Compliance: The forest land will not be used for establishing labour camps.

Condition No.(12). The sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.

Compliance: SCCL is providing free supply of LPG to all its employees @ 12 cylinders per annum.

Condition No.(13). The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.

Compliance: The area has been demarcated with RCC pillars of 4 feet height 22 Nos. of pillars have been fixed, details are as follows:







Accordingly, SCCL submitting annual condition-wise compliance report as detailed below.

Condition (a) : Legal status of the forest land is unchanged.

Compliance: Yes. The legal status of the forest land is remained unchanged.

Condition (b): Compensatory afforestation will be carried out over equivalent non-forest land at the cost of User Agency.

Compliance: SCCL paid cost of CA Charges as detailed below:

- 1) Rs.108.00 lakhs vide cheque no.380651 dt.24.2.2001 to DFO, Khammam (Treasury Challan No.678 dt.30.3.2001)
- 2) Rs.8.434 lakhs vide cheque no.380649 dt.24.2.2001 to DFO, Paloncha (Sub-treasury Kothagudem Challan no.1131 dt.21.3.2001)

Condition(c): The non-forest land transferred to Forest Dept., for compensatory afforestation shall be declared protected forest / Reserve Forest under Indian Forest Act, 1927.

Compliance: SCCL handed over equivalent extent of non-forest land as detailed below:

The concerned Authorities have to take steps for declaration.

Condition (d): Lease period shall be for 30 years i.e. date of issue of this letter.

Compliance: Yes. Lease was granted for 30 years under MMRD Act from 14.5.2001 to 13.05.2031.

Condition (e): Phased reclamation plan will be implemented by the user agency at their cost.

Compliance: The phased reclamation is being implemented as per approved EMP and communicated vide GOI letter no.J-11015/312/94-IA,ii(M) dated 10-12-2001. So far reclamation was done in 229 Ha out of total diverted area of 236 Ha. The 229 Ha is covered with plantation.

Condition (f): The forest land shall not be used for any purpose other than that specified in the proposal.

Compliance: The forest land is used for the purpose indicated in the proposal.

Condition (g): Fencing, protection and regeneration of the safety zone area will be done at the project cost besides this, afforestation over one and half-times of safety zone area in degraded forest elsewhere will be done at the project cost.

Compliance: Already trench cutting was done around the diverted forest area of 236 Ha. Bund was established around the periphery of the diverted forest area and plantation was done. SCCL deposited an amount of Rs.7, 87,900/-towards the cost of enrichment plantation vide Cheque No.380650 dt.24.2.2001 to DFO, Kothagudem

Condition (h): Demarcation of mining lease area will be done on the ground using four feet high reinforced cement concrete pillars with serial numbers, forward & back bearings and distance from pillar to pillar at project cost.

Compliance: SCCL has grouted 35 Nos. of 4 feet height reinforced cement concrete pillars all around the mining lease hold area. The details of co-ordinates, bearings and distances are furnished below:

Condition (i): The approval under the Forest (Conservation) Act, 1980 is subject to the clearance under the Environmental Protection Act, 1986.

Compliance: SCCL has obtained EC vide MOEF (GOI) letter No. J-11015/312/94-IA, II (M) dated 10-12-2001.

Condition (j): Adequate measures will be taken to compensate the bonafide users of the part of forest land as per the guidelines of the State Government.

Compliance: The SCCL has already given an undertaking to compensate the bonafide users of the part of the Forest land as per the guidelines issued by the State Government.

The MRO vide his letter dated 24-06-2000 confirmed that no pattas were granted in the area diverted for KOCP. Hence the occupants/users of the land are only encroachers in RF Area. Consequent to sanction of the area for KOCP, the encroachers have vacated the area.

Condition(k): The User Agency will make arrangement for free supply fuel wood preferably alternate energy source to labourers and staff working on the project site so as to avoid any pressure on the adjacent forest areas.

Compliance: LPG gas is being supplied to all the employees of SCCL, Yellandu Area at free of cost.

Condition (l): Any other condition which the State Government or Chief Conservator of Forests (Central) Regional Office, Bangalore may stipulate from time to time in the interest of afforestation and protection and improvement of flora and fauna of the area.

Compliance: Any other condition imposed by State Government & MoEF will be complied with.

Accordingly, SCCL submitting the annual condition-wise compliance report as detailed below.

Condition No.1: Legal status of the forest land shall remain unchanged.

Compliance: Yes. The status of RF land remained unchanged.

Condition No.2 (a): Compensatory afforestation shall be raised and maintained by the State Forest Department at the Project Cost.

Compliance: SCCL handed over equivalent extent of non-forest (CA) land as detailed below:

Condition No.2 (b): Fencing, protection and regeneration of the safety zone area (100 meters strip all along the outer boundary of the mining lease area as recommended by the State Government) shall be done at the project cost. Besides this, afforestation on degraded forest land, to be selected elsewhere, measuring one and a half times the area under safety zone shall also be done at the project cost.

Compliance: SCCL paid an amount of Rs.8.630 lakhs towards cost of afforestation in 1 ½ times of safety zone area (10.31 Ha.), Rs.5.75 lakhs towards cost of regeneration of safety zone area (6.87 Ha); vide cheque no.289859 dt.20-2-2007 to DFO, Kothagudem. Rs.3.114 lakhs towards charges for Trench cutting around safety zone area vide DD.No.272703 dt.7-4-2007 to DFO, Kothagudem.

Regarding plantation in 100 mtrs.safety zone, as most of the area around the diverted forest land is under encroachment, SCCL requested PCCF to take up the matter with MOEF to modify the condition. However SCCL is ready to take up the plantation as advised by the State Forest dept.

Condition No.2(c) : Wherever possible and technically feasible, the User Agency shall undertake afforestation measures in the blanks within the lease area, as well as along the roads outside the lease area diverted under this approval, in consultation with the State Forest Department at the project cost.

Compliance: Identified 20Ha of blank land along roads and misc. areas and details of plantation work taken up is as follows:

- i) 3 kms of Avenue Plantation was done either side of road from Petramchelika to KOC Mine in 2006-07.
- ii) 9 kms of Avenue Plantation was done either side of road from Petramchelika to Tekulapally in 2010-11.
- iii) 2.00 Ha of plantation made at blank areas.

Condition No.2(d): The non-forest land identified for raising Compensatory Afforestation shall be notified by the State Government as RF under Section-4 or PF under Section-29 of the Indian Forest Act, 1927 or under the relevant Section(s) of the local Forest Act, as the case may be, within a period of six months. The Nodal Officer (Forest Conservation) shall report compliance in this regard)

Compliance: SCCL identified equivalent non-forest land in Gondigudem (V), Bhadrachalam (South) and Thumukunta (V), Cuddapah district and handed over the same to Forest Department as mentioned against condition No.2 (a). The Status of notification of these areas as protected forest to be furnished by State Forest Dept.

Condition No.3: Following activities shall be undertaken by the User Agency at the project cost.

- (i) Proper mitigative measures to minimize soil erosion and choking of streams shall be prepared and implemented.

Compliance: Around 9,500 Kgs. of Hemata, Babul, Sesaboina, Stylo seeds were sown on OB dumps to prevent soil erosion. Desilting of seasonal nallah along the East side of the Pit-II is being carried out, whenever it is required.

Condition No.3 (ii): *Planting of adequate drought hardy plant species and sowing of seeds to arrest soil.*

Compliance: Around 20,80,000 Nos. of Dendrocalamus strictus, Hardwickia binate, Pterocarpus santalinus, Aegle marmelos, Ficus benghalensis, Terminalia.bellarica (Tani), Albezia odoratissima, Emblica officinalis, Pterocarpus marsupium, Inga dulce, Azadirachta indica, Simarouba gluca, Tamarind, Ficus religiosa, Dalbergia latifolia, Pongamia pinnata, Bombox, Madhuca indica, Ficus carica (Medi), Ficus mollis, Tchebula, Mytragyna parvifolia, Ficus mollis, Tapsi, etc., Plants were grown covering an area of 229 Ha of adjacent mine dump area to prevent Soil erosion.

Condition No.3 (iii): *Construction of check dams, retention / toe walls to arrest sliding down of the excavated material along the contour.*

Compliance: Total 7.20 KMs. Length of rock toe/retention walls are made around the OB dumps. 1 No. Check Dams and 2 Nos. Siltation Ponds are made in garland drains to prevent run-off water.

Condition No.3 (iv): *The areas shall be reclaimed keeping in view the international practice of stabilizing the dumps by grading / benching so that angles of repose (normally less than 28 at any given place) are maintained.*

Compliance: At present, 694.09 LBCM of OB was removed and dumped at the earmarked OB dumpsite at a maximum height of 50m only consisting of 2 benches of 30m+20m height. The ultimate slope of dump is maintained not exceeding 28 degrees.

Condition No.3 (v): *The top soil management plan should be strictly adhered to*

Compliance: Strictly complied. Around 5.252 M.Cu.M of top soil is spread over the OB Dumps for plantation.

Condition No.4: *The forest land shall not be used for any purpose other than that specified in the proposal.*

Compliance: The forest land is being used for the purpose for which it is proposed and approved.

Condition No.5: *The approval under the Forest (Conservation) Act, 1980 is subject to the clearance under the Environmental Protection Act, 1986.*

Compliance: Yes. EC was obtained vide MoEF letter no.J-1015/306/2006-IA.II (M) dated 11.6.2007

Conditions No.6: *The User Agency will make arrangement for free supply of coal to labourers and staff working on the project site so as to avoid any pressure on the adjacent forest areas.*

Compliance: LPG gas is being supplied to all the employees of SCCL, Yellandu Area at free of cost

Condition No.7: *The period of permission for lease under the Forest (Conservation) Act, 1980 will be for 20 years subject to possession of valid lease by User Agency under the MMDR Act. 1957.*

Compliance: Yes. Lease was granted under MMDR Act, for 20 years from 26-02-2008 to 25-02-2028.

Condition No.8: *Demarcation of mining lease area will be done on the ground at project cost using four feet high reinforced cement concrete pillars with serial numbers, forward & back bearings and distance from pillar to pillar.*

Compliance: Mining lease area is demarcated on ground with 113 Nos. of 4 feet height reinforced cement concrete pillars with serial numbers, forward & back bearings and distance from pillar to pillar was written on pillars. The details are furnished below:

Condition No.9: Mining/reclamation schedule shall be implemented by the user agency at their cost as per Environmental Management Plan/phased programmed

Compliance: SCCL is adhering the mining & reclamation as provided under approved EMP. So far, an amount of Rs.583.91 Lakhs were spent towards Environmental and Pollution control measures(Cost of Water management Rs.98.03 lakhs; Cost of dust prevention Rs.208.75 lakhs; Cost of afforestation Rs.157.13 lakhs and Cost of wages Rs.120.00 lakhs) by SCCL at Koyagudem Opencast Project.

Condition No.10: The User Agency shall take up suitable rehabilitation of the people (cultivators), who are cultivators of land at the cost of the User Agency as recommended by the State Government.

Compliance: SCCL has rehabilitated the cultivators as per the R&R Scheme prepared and approved by the District Administration by paying Rs.243.98 lakhs as per the R&R Policy of State Govt.

Condition No.11: Any other condition that the State Govt. or the Chief Conservator of Forests (Central), Regional Office, Bangalore may impose from time to time in the interest of conservation, protection or development of forests.

Compliance: Any other condition, if imposed will be complied with.
