## Detailed Violation Report

दिनांक 19.10.2021 को सुलतानपुर से कंवारी रोड पर हल्का वन रक्षक/वन दरोगा द्वारा गस्त की गई, जिसके दौरान पाया गया कि सुलतानपुर से कंवारी रोड पर बिजली विभाग द्वारा नाजायज रूप से बिजली की डाली पाई गई। इस प्रकार प्रयोक्ता एजेंसी द्वारा प्रस्ताव में IFA 1927 की उल्लंघना की गई है। इस उल्लंघना के लिये प्रयोक्ता एजेंसी के खिलाफ डी0आर0 नं0 034 दिनांक 19.10.2021 चाक कर दी गई (प्रति सलगन)। अब प्रयोक्ता एजेंसी द्वारा दिनांक 29.09.2020 को एफ0सी0ए0 का प्रस्ताव परिवेश पोर्टल पर मंजूरी हेतु ऑनलाईन करते हुए मण्डल कार्यालय में प्रस्तुत किया है।

Area of 0.5322 ha. of forest land in favour of Executive Engineer, Transmission System Division, HVPNL Hisar for creation of 132 KV S/C Line with 0.4 Sq. Zebra conductor from 132 K.V S/Stn. Bhojraj to 132 KV S/S Arya Nagar & LILO of One Line Circuit of 132 KV D/C Sangwan to Khanak Line at 132 KV S/Stn. Bhojraj Line on 132 KV D/C KRR Design Towers under forest- Division & Distt. Hisar Haryana.

Penalty for violation as per provisions of Sr. No. ii (a) Para 1.21 Chapter - 1 of Handbook of Forest (Conservation) Act 1980 and Forest Conservation Rules, 2003 (Guidelines & Clarifications) - 2019. The penalty for violation shall be equal to NPV of forest land per hectare for each year of violation from the date of actual diversion as reported by the inspecting officer with maximum upto Five (5) times the NPV plus 12 percent simple interest till the deposit is made.

Actual NPV of the Case i.e NPV of the forest land to be diverted = 484036.00

Period of violation:- From 01-01-2021 to 31-12-2021 = 365 (Number of days under violation as per telephonic information of JE, HVPNL)

**Calculation for amount of NPV for penalty/violation**

Actual NPV of case x Period of violation i.e number of days under violation/365 = .....(It is the amount of NPV for penalty/violation)  $484036 \times 365 / 365 = 484036$  (for 365 days)

**Simple Interest @ 12% p.a**

Amount of NPV for penalty/violation x 12 x number of days under violation / 365/100 = .....(It is amount of Penalty for violation)  $484036 \times 12 \times 365 / 365 / 100 = 58084$


**Total amount of Penalty for violation**

Amount of NPV for penalty/violation + Amount of Interest = .....(It is total amount of penalty for violation)

$484036 + 58084 = 542120.00$
