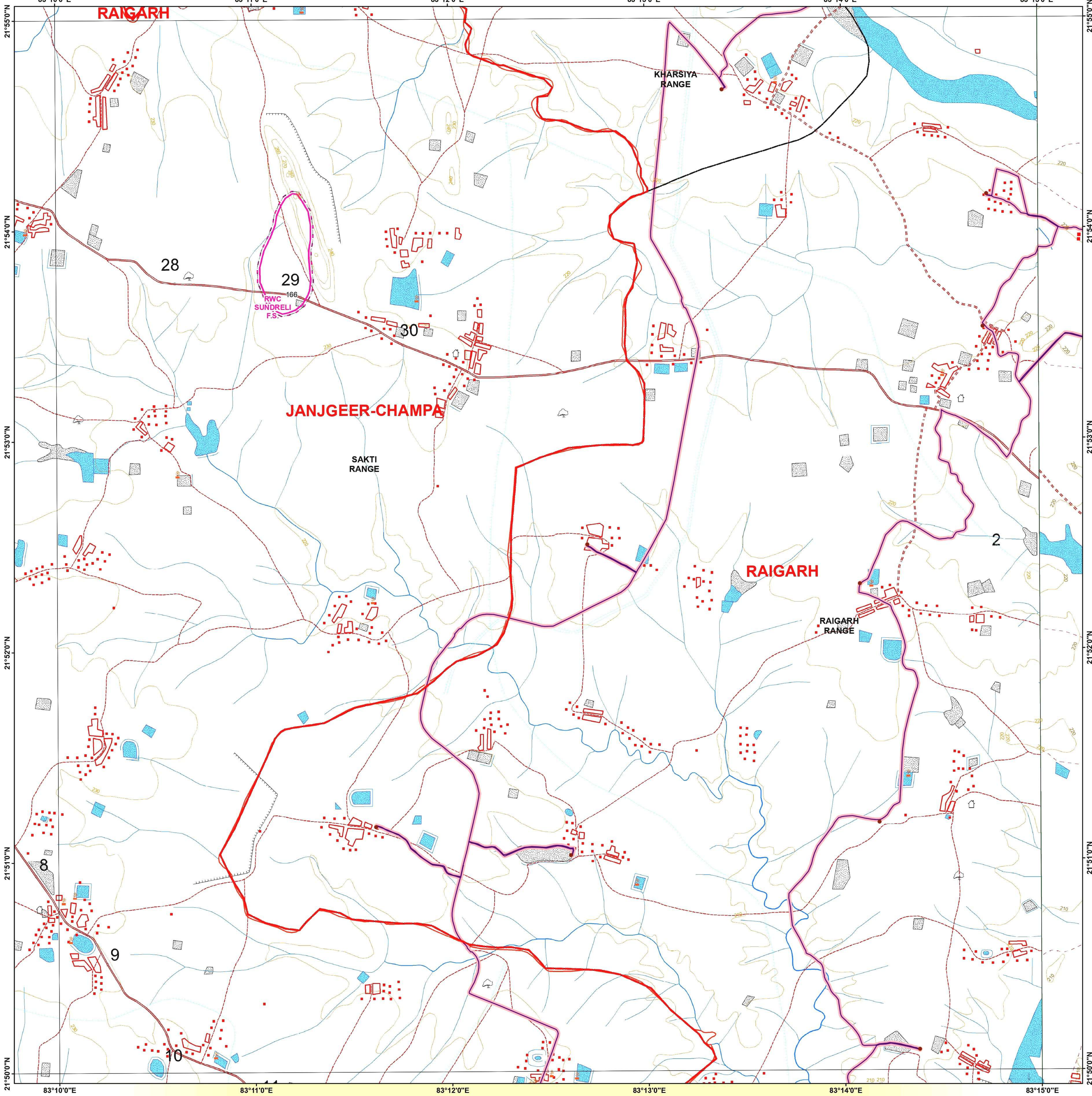


Stock Map of Janjgeer-Champa Division
