- 3. The Proposal was passed unanimously that in all the villages the rights of tribal communities and tribal farmer communities are specially protected according to section 3 (1)(e) of the scheduled tribes and other traditional forest resident (Recognition of Forest Rights) Act 2006.
- 4. The Proposal was passed unanimously that all the processes have been completed in respect of the proposal of forest land diversion in all villages as per Rights of scheduled tribes and other Traditional Dwellers (Recognition of Forest Rights) Act 2006
- The Proposal was also passed unanimously that the District Forest Rights committee, Chatra, has no objection in Diversion of the land as per the aforementioned details.
- This NOC cannot be considered as acceptance for diversion. Prior permission and NOC for Diversion of shall be obtained by the project proponent under the Forest Conservation Act of 1980 from the Ministry of Environment and Forest, Government of India.
