Reference is invited to PFCCL's letter under reference, seeking prior approval of Government of India under Section 68 (1) of Electricity Act, 2003, in favour of M/s Fatehgarh – II Transco Limited, the SPV for the transmission scheme ‘Transmission system associated with LTA Applications from Rajasthan SEZ Part - B’ with following scope of works:


- The transmission scheme ‘Transmission system associated with LTA Applications from Rajasthan SEZ Part - B’ was agreed in the 2nd meeting of Northern Region Standing Committee on Transmission held on 13.11.2018.
- Further, in the 3rd meeting of the Empowered Committee on Transmission held on 21.12.2018, the above scheme was decided to be taken up through Tariff Based Competitive Bidding. MoP has appointed M/s PFC Consulting Ltd. as Bid Process Coordinator (BPC) for the above scheme vide Gazette notification dated 01.02.2019.

4. CEA conveys prior approval of Government under Section 68 (1) of Electricity Act, 2003 to M/s Fatehgarh – II Transco Limited for implementation of the following overhead transmission line under the scheme “Transmission system associated with LTA Applications from Rajasthan SEZ Part – B”.
 - Fatehgarh-2 – Bhadla-2 765 kV D/C line.
5. This approval is subject to compliance of
 - a) The relevant provisions of the Act, as amended from time to time and the rules and regulations made there under, and
 - b) CEA (Measures relating to Safety and Electrical Supply) Regulations, 2010 and any subsequent amendments made thereto.
6. The approval is also subject to the following conditions:
 - (i) The implementing agency will commence construction of the project within three years of grant of approval, unless this term is extended by the Central Electricity Authority.
 - (ii) Central Electricity Authority may withdraw the approval before the expiry of the period of three years after giving a one-month notice.
 - (iii) The implementing agencies shall abide by the provisions of Works of Licensee Rules, 2006 notified by the Govt. of India, Ministry of Power in the Gazette of India, extra-ordinary Part-II, Section 3(i) dated 18-04-2006 (vide GSR 217 (E) dated 18-04-2006).
