As per route diagram submitted by you, permission is hereby accorded for laying optical fiber cable by HDD on KRLL0130-23 MH2400 meters to be done ITI chowk, SBI, ATM, Kunjpura road, Adarsh School, Gurudwara Nanak Darbar, Prachi Book Shop, Vasant Vihar Road, Sonu Pair Sallon Haryana subject to the following conditions:-

1. The work could be done by telecom ducts / cables by trenching / HDD method.
2. That you will ensure that the work will be done at the edge of ROW within 1 meter of PWD land.
3. The amount deposited by you is not refundable.
4. That you will ensure smooth flow of traffic during execution of work.
5. That you will back fill the earth and restore the land to its original shape on the same day.
6. That you will take all safety measure during execution of work as per IRC specifications.
7. That you will ensure no damages is caused during laying of cable to the existing services like water supply lines, sewerage lines and telephone line etc. and if such damage occurs then you will repair the same at your own cost.
8. That you will remove / shift the cable at your own cost whenever required by the Deptt.
9. That the permission is valid for 5 years and should be renewed after every 5 years.
10. If any type of violation will be made as per agreement, the deptt. will have the right to demolish / stop up the work.
