2. The grant of this lease shall be subject to the following terms and condition:
- Payment of fee, security deposit and financial assurance will be made as per Rule 34, Rule 35, and Rule 40 of the Manipur Minor Mineral Concession Rules, 2012.
 - The lessee is required to submit Mining Plan as provided under Rule 39(4) of the Manipur Minor Mineral Concession Rules, 2012.
 - The lessee shall strictly adhere to the conditions laid down in Rule 39 of the Manipur Minor Mineral Concession Rules, 2012;
 - The lessee shall comply with the related provisions of Forest (Conservation) Act, 1980 and Environment (Protection) Act, 1986 and other rules and Notifications as amended from time to time.
3. The Quarrying Lease Deed shall be executed in prescribed Form-H within six months from the date of receipt of this order as per Rule 43 of the Manipur Minor Mineral Concession Rules, 2012 after fulfilling the conditions required in Sl.No.2(i) and 2(ii) above.
