



Now at the request of Divisional Engineer (Telecom Project) Jalandhar, BSNL, we Union Bank of India (UBI), a banking company, having its Head office at Union Bank Bhawan, 239, VidhanBhawan Marg, Nariman Point, Mumbai-400021 represented by its branch office at 14/15-F,Connaught Place, New Dehli -110001 (hereinafter referred to as a "the bank" which expression shall, unless it be repugnant to the subject or context thereof include its successors and assigns) undertake to pay to the Principal an amount not exceeding Rs. 4,75,000/-(Rupees Four Lakh Seventy Five Thousands only) against any loss or damages caused to or suffered by the Principal, by reasons of any breach by the terms and conditions contained in the said Agreement.

2. We Union Bank of India 14/15-F,Connaught Place, New Delhi -110001 do hereby undertake to pay the amount due and payable under this guarantee without any demur, merely on a demand from the Principal stating that amount claimed is on account of making good the executed trench for laying OF Cable from Ludhiana(Ayali Kalan) to Bhundri (Ludhiana-Jagraon OFC Route) for the length of 19000 meterby proper filling and compaction, as to store the land in the same conditions as it was before digging the trench, debris/ loose earth produced due to execution of trenching.
