



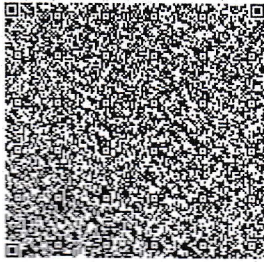

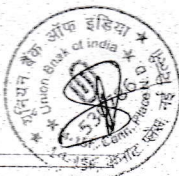

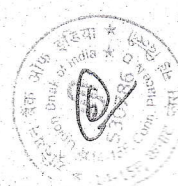
1. While **Divisional Engineer (Telecom Project) Bharat Sanchar Nigam Limited, Bhagu Road Bhatinda**, (herein referred to as "BSNL") has sought permission to lay underground Optical Fibre Cable in the area falling under **The Divisional Forest Officer Ludhiana**, (herein after referred to as '**Principal**') who has agreed to accord permission to lay the underground cable subject to signing of an agreement and submission of bank guarantee for fulfillment of conditions of the agreement.

Now at the request of Divisional Engineer (Telecom Project) Jalandhar, BSNL, we **Union Bank of India (UBI)**, a banking company, having its Head office at Union Bank Bhawan, 239, VidhanBhawan Marg, Nariman Point, Mumbai-400021 represented by its branch office at 14/15-F, Connaught Place, New Dehli -110001 (hereinafter referred to as a "the bank" which expression shall, unless it be repugnant to the subject or context thereof include its successors and assigns) undertake to pay to the **Principal** an amount not exceeding **Rs. 4,75,000/- (Rupees Four Lakh Seventy Five Thousands only)** against any loss or damages caused to or suffered by the Principal, by reasons of any breach by the terms and conditions contained in the said Agreement.

2. We **Union Bank of India 14/15-F, Connaught Place, New Delhi -110001** do hereby undertake to pay the amount due and payable under this guarantee without any demur, merely on a demand from the Principal stating that amount claimed is on account of making good the executed trench for laying OF Cable from **Ludhiana(Ayali Kalan) to Bhundri (Ludhiana-Jagraon OFC Route)** for the length of **19000 meter** by proper filling and compaction, as to store the land in the same conditions as it was before digging the trench, debris/ loose earth produced due to execution of trenching. However, our liability under this guarantee shall be restricted to **Rs.4,75,000/- (Rupees Four Lakh Seventy Five Thousands only)**.

3. We undertake to pay to the **Principal** any money limited to **Rs. 4,75,000/- (Rupees Four Lakh Seventy Five Thousands only)** so demanded not withstanding any dispute or disputes raised by BSNL in any suit or proceeding pending before any court or tribunal relating there our liability under this present being absolute and unequivocal. The payment so made by us under this bound shall be valid discharged of our liability for payment there under & BSNL shall have to claim against us for making such payments.

4. We **Union Bank of India 14/15-F, Connaught Place, New Delhi -110001** further agree that the guarantee herein contained shall remain in full force and effect during the period that would be taken for the performance of said agreement and that shall be continued to be enforceable till all the dues of the Govt. under or by virtue of the said agreement have been fully paid and its claim satisfied or discharged or till the **Principal** certify that the terms and conditions of the

said agreement have been fully and properly carried out by the said BSNL and accordingly discharges this guarantee or till 26.10.2016..... whichever is earlier, unless a demand or claim under this guarantee is received by us in writing on or before twelve months from the date of issue i.e. on or before 26.10.2016..... We shall be charged from our liabilities under this guarantee thereafter.

5. The guarantee will be discharged due to the change in the constitution of the **Bharat Sanchar Nigam Limited**.
6. Notwithstanding anything contained herein:-
1. Our liability under this guarantee shall not exceed **Rs. 4,75,000/- (Rupees Four Lakh Seventy Five Thousands only)**.
11. This Bank Guarantee shall be valid upto 26.10.2016 and
