District Magistrate,FZD ...vide letter no 408./.12-01-23 ...has forwarded the above proposal for the issuance of NOC of UPPWD. The proposal was examined and processed by Executive Engineer, CONSTRUCTION Division, 2 UPPWD, FZD. and recommended by Superintending Engineer, MAINPURICircle UPPWD, MAINPURI for issuance of Provisional Permission/NOC as per Existing Guidelines.

Authority after due considerations hereby approves "Provisional Permission for access" in accordance with "Uttar Pradesh Guidelines for issuing of "NOC for setting up fuel stations along UPPWD Roads-2022", under provision of "Section-5" of "Uttar Pradesh Road Side land Act-1945" subject to following conditions.

- 1. After obtaining this 'Provisional approval, Oil Companies / Owner shall be responsible for the construction and maintenance of deceleration / acceleration lanes, service roads, channelizes, drainage arrangement, drinking water & toilet facilities, signs and markings and other facilities in accordance with the approved layout and specifications conforming the Guidelines, at own cost.
- 2 On completion of the construction in accordance with checklist and conforming to the approvals, Completion Certificate shall be issued, by the Executive Engineer of PWD for approval of Competent Authority.
- 3. The concerned Oil Company would be allowed to energize the fuel station only after the final approval by Competent Authority. In the event fuel station is energized with out seeking Final approval (Final NOC) necessary action may be initiated against the applicant as per Guidelines of "Uttar Pradesh Guidelines for issuing of NOC for setting up fuel stations along UPPWD Roads-2022" including but not limited to cancellation of Provisional Permission for Access.
- 4. The prescribed processing fees, license fee has been deposited by applicant and BG/NSC no 06030GPGE2303001 For Rs 250,000/- issued by Bank .CANARA.BANK validity upto 01.02-2026... (towards successful completion of the access roads and installation of fuel station) has also been submitted by the applicant. The BG/NSC shall be released by Authority with in 30 days of grant of Final NOC. In case the construction is not completed with in stipulated period of 12 Months, or any extended period duly approved by competent authority, Authority may encash the BG/NSC submitted by applicant.
- In case the sitting of proposed fuel station is not found in accordance with "Uttar Pradesh Guidelines for issuing of NOC for setting up fuel stations along UPPWD Roads-2022" and as per approved drawings, the permission shall stand cancelled and UPPWD shall not be responsible for any claim/damage/loss to the oil company or any concerned person.

- 6. The Guidelines contained in "Uttar Pradesh Guidelines for issuing of NOC for setting up fuel stations along UPPWD Roads-2022" shall be followed strictly in setting up fuel station.
- 7. It shall be ensured by Executive Engineer to deposit the prescribed land use fee in state Govt revenue head as per Guidelines.
- 8. The Original land Use Deed duly signed on each page by Oil company's authorized Officer and Executive Engineer shall be kept in Zone office with a certified copy in Division and Circle Office.
- 9. It shall be ensured by the Divisional staff to inspect the Fuel Station regularly and in case of any dafaults/deviations found, action will be taken as per Guidelines to get it rectified with in 60 days from the date of Inspection. The failure to rectify the identified deficiency with in prescribed time, the necessary action regarding De-energization shall be initiated.
- 10. The division shall enter details of In-principle Approval of NOC of Fuel station, issuance of completion certificate, and other necessary details of Fuel station in "Divisional Register of Fuel stations". The photographs and videos as per clause 3.1 of Guidelines shall be kept in records.
- 11. A copy of In-principle Approval of NOC of Fuel station shall be sent to Oil company by Registered Post/Speed post and on registered e-mail of Oil company with the instructions to energize the Fuel station only after obtaining Completion Certificate as per stipulated norms.
