As per the condition no (viii) of the approval dated 14.11.2005, the User Agency has submitted an undertaking to raise, fence and maintain a safety zone around the mining area and to raise and maintain plantation over an area one & half times in extent of the safety zone at their own cost. (c): The DFO, Keonjhar Division has reported that the UA has deposited Rs.20,23,420/- towards Regional Wildlife Management Plan over 101.171 ha, but the balance amount has not been paid by the UA. So, it needs to be complied.

The user agency has already identified 9.800ha of non-forest Govt.land in Champajhar village of Banspal Tahasil scheme prepared the C.A. with provision therein for ANR with Gap plantation @200 seedlings/ha. To accommodate the balance seedlings 7840 nos.(9800-1960=7840)additional CA scheme has been prepared over 16 ha of degraded forest land identified in Baunsuli RF under Patna Forest Range of Keonjhar Division with provision for ANR with Gap plantation model @500 seedlings/

Further the Collector, Keonihar has allotted Non-Forest Govt. land over 66.745ha in village Gundula under BJP Range of Banspal Tahasil of Keonjhar district and accordingly, the C.A. Scheme has been prepared for AR plantation @1000 seedlings per ha over 33.00 ha as per Decision Support System (DSS) .
