Kindly refer to above correspondences from your office regarding our proposal for providing approach way to Mines from Tosham-Hisar road. Your office had raised issue of use of Forest Department owned land by HSI IDC as an approach to mines without permission.

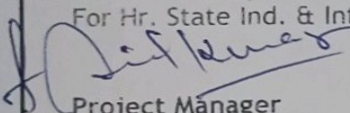
In order to address the issue, HSI IDC had filed online application seeking permission from your Department for an appropriate Right of Way from Hisar Tosham Road. Against this request in a later communication from the Department HSI IDC was advised to provide alternate Non-Forest land measuring 0.1785 ha for afforestation.

It is informed that the Haryana State Industrial & Infrastructure Development Corporation Limited (HSI IDC) has been appointed by the State Government to operate the Stone Mine in Village Khanak, Tehsil Tosham District Bhiwani to achieve certain public objectives including systematic mining, material availability etc. The land parcel of 258 hectare, on which the mining activity is being undertaken by HSI IDC, belongs to the State Development & Panchayats/Mining Department and leased out to the Corporation for 20 years (upto 2033).

Since the Project Land belongs to/is owned by Mining & Panchayat Departments, transfer/exchange of land can be enabled/permited by the aforementioned Departments only. While we are earnestly taking up the matter with these Departments for enabling transfer/exchange of the suitable land parcels, a final decision by the Department(s) is expected to take some time. In the meantime, HSI IDC may be permitted to continue unhindered operations so that the public objective remains duly serviced.

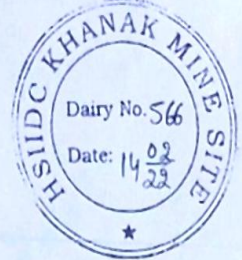
