The process has been culminated by preparation of the plans under the said component in consultation with the entire line department including you, which has been got approved/ sanctioned for the concerned quarters already for the amount proposed under the plan.

The further process requires another deliberate discussion in the matter, as was previously held, before sending proposal to the higher ups as per the approved R&R plan.

However, in view of the urgent work nature, as apprised by the Chief General Manager Pakal Dul HEPP vide No:- CVPP/PDHEP/CGM/2020/78A Dt:-18.07.2020 & CVPP/PDHEP/CGM/2020/675 Dt:- 01.07.2020 and as requested by you in the interest/ smooth functioning of the project work, you are hereby requested to proceed further in the matter as per the already approved proposal (amounting to Rs. 93.99 lacs). The hike/ excess amount for the said work shall be taken up with the higher authorities (approving authority as per approved R&R Plan) and as and when, the approval is received from the concerned quarters, same shall be communicated to you.
