- Industry will not start its operation, unless CTO is obtained under water (Prevention and control of 4. Pollution) Act, 1974 and Air (Prevention and control of Pollution)Act, 1981 from the Board
- It is mandatory to submit Air and Water consent Application, complete in all respect, four months 5. before start of operation, to the U.P. Pollution Control Board.
- Legal action under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and 6. Control of Pollution) Act, 1981 may be initiated against the industry With out any prior information, in case of non compliance of above conditions.

## Specific Conditions:

- 1. This CTE is granted for establishment at Gata No-112Mi, 113Mi & 114Mi Vill-Mustafabad Tehsil and District-Moradabad for storage of H.S.D. (Diesel)-22.0 KL & M.S.-(Petrol)-22.0 & 16.0 KL only.
- 2. The Retail outlet shall comply with various provisions of Water (Prevention and Control of Pollution) Act 1974 as amended & Air (Prevention and Control of Pollution) Act 1981 as amended and all other applicable rules notified under Environment (Protection) Act 1986.
- 3. This CTE valid for discharge of domestic effluent only
- 4. Domestic waste water discharged through septic tank soak pit.
- 5. Until Shall develop Green Belt in minimum 33% area of Industrial Premises as per the provisions laid down in office order no.H16405/220 2018 02 dated 16-02-2018 of U.P. Pollution Control Board The copy of said office order is available on the website of U.P. Pollution Control Board www.uppcb.com.
- 6. Retail Outlet should install rainwater harvesting system for recharge of ground water.
- 7. Retail Outlet should comply all the directions of M/s Hindustan Petroleum Corporation Ltd.
- 8. Land conversion certificate should be submitted within three month. If same shall not be submitted within three month hence CTE will be deemed cancelled.
- 9. NOC from Explosive Department and Fire Safety Department shall be obtained.
- 10. Unit should be obtained necessary permission from district administration and other concern department and should comply all the condition as applicable.
- 11. Proposed D.G. Set 15 KVÁ I No. must be equipped with Acoustic Enclosure and suitable air pollution/noise pollution control devices and emission and noise level of D.G. Set must conform to the prescribed standards.
- 12. Retail outlet shall comply directions of petroleum explosive safety organization (PESO).

13. Retail outlet should be installed volatile recovery system.
